V. HIGH COMMENDATIONS

1) On November 4, 1994, Fire Fighter Thomas C. White, Engine Company 8 and Fire Fighter William J. Blackstone, Ladder Company 1, were working a paid detail at 51 Blossom Street, District 3. At approximately 1335 hours, Fire Fighter Thomas C. White noticed smoke coming from a window of an adjacent building at 33 Blossom Street. He then instructed a Boston police officer to notify the Fire Alarm Office, and he and Fire Fighter William J. Blackstone picked up two extinguishers and proceeded to the fire building. Upon entering the apartment, they found an elderly woman lying semi-conscious on the floor and a sofa fully involved in flames. The fire fighters removed the victim and re-entered the apartment and were able to hold the fire, preventing flashover and undoubtedly saving the woman's life.

Because of their swift actions, under great personal risk, the Fire Commissioner is pleased to highly commend Fire Fighter Thomas C. White of Engine Company 8 and Fire Fighter William J. Blackstone of Ladder Company 1 and refers their case to the Board of Merit for further consideration.

2) On December 31, 1994, at 0755 hours, Incident #57020, Box 5127 was struck for a building fire at 13 Pratt Street, Allston. Upon arrival, heavy fire was reported on the first and second floors and a person reportedly was trapped on the third floor. The incident commander ordered Fire Fighter Gregory Fall, Ladder Company 14, to conduct a search of the third floor. Fire Fighter Fall ascended Ladder Company 14's aerial and entered a third floor window, encountering extreme heat and heavy smoke conditions. Crawling around the apartment he came upon a bed and, not finding anyone in it, he continued searching around the floor and located an unconscious man next to the bed. Fire Fighter Fall dragged the victim to the window where he was assisted by other members who removed the victim down the aerial ladder to safety.

Because his actions were performed under zero visibility and extreme heat conditions, before adequate ventilation and without benefit of a charged line and under extreme personal risk, the Fire Commissioner is pleased to highly commend Fire Fighter Gregory Fall of Ladder Company 14 and refers his case to the Board of Merit for further consideration.

Specific authority is hereby delegated to the said Deputy Fire Chiefs, District Fire Chiefs, Fire Captains, Fire Lieutenants, Fire Fighter Inspectors of the Fire Prevention Division, Fire Fighters in the Fire Fighting Force, Fire Department Chemist, Senior Analytical Chemist, Fire Department Plans Examiners, Special Hazard Police Officer, Fire Investigation Police Officers, Superintendent of the Special Services Division and those designated by him as Inspectors of Fire Alarm Systems, to make investigations and inspections and to issue orders in writing pursuant to the provisions of said actions.

V. HIGH COMMENDATIONS

1. On January 4, 1995, at 1111 hours, Incident #547, Box 2152 was struck for a building fire at 16 Rockland Street, Roxbury. Upon arrival, companies reported heavy fire on the first floor, extending to the second floor. At this time, a woman on the street was screaming that her baby was on the second floor. Fire Lieutenant John L. Collins of Ladder Company 4 entered the building and, passing fire, he proceeded to the second floor. At the top of the stairs he entered a bedroom on the left, located an infant in a bassinet and safely removed the infant to the street.

Because his actions were performed under extreme personal risk, before charged lines were in place and before ventilation was accomplished, the Fire Commissioner is pleased to highly commend Fire Lieutenant John L. Collins of Ladder Company 4 and refers his case to the Board of Merit for further consideration.

2. On January 16, 1995, at 2137 hours, Incident #2606, Box 2363 was struck for a building fire at 158 Ward Street, Roxbury. Upon arrival, heavy smoke was pushing from a three story apartment building and civilians reporting a woman trapped in an interior bedroom on the first floor. Fire Fighter Charles J. Papineau of Ladder Company 26 forced his way into the apartment, passed through a heavy fire condition into the living room, worked his way into the rear bedroom where he found an unconscious woman on the floor. He then removed his face piece and placed it on the woman's face. At this point, he was assisted by another firefighter in removing the unconscious, burned woman to safety.

Because his actions were performed under great personal risk with heavy smoke and fire conditions and without the benefit of charged lines and ventilation, the Fire Commissioner is pleased to highly commend Fire Fighter Charles J. Papineau of Ladder Company 26 and refers his case to the Board of Merit for further consideration.

3. On March 5, 1995, while vacationing in Florida, Fire Fighter James M. Hardy of Rescue Company 1 observed a woman submerged in water where she had fallen from a pier. He dove into the water and pulled the victim to safety. Because of his quick actions, Fire Fighter Hardy possibly prevented permanent injury or death to the victim.

While reflecting credit upon himself and the Boston Fire Department, the Fire Commissioner is pleased to highly commend Fire Fighter James M. Hardy of Rescue Company 1 and refers his case to the Board of Merit for further consideration.

EMERGENCY MEDICAL INCIDENTS

The Boston Fire Department responded to a record number of 54,835 incidents in 1994, the highest total of calls since 1979. Our response to emergency medical incidents increased significantly last year as we responded to 16,253 EMS incidents.

As the department continues to meet the many challenges in the emergency medical field, our mission to ensure that Boston residents receive the highest quality emergency medical response depends on a close working relationship between the Department of Health and Hospitals Emergency Medical Service and the Boston Fire Department. This relationship is dependent upon the ongoing cooperation, professionalism and commitment of both departments to high quality medical responses.

During the last few weeks representatives from the Boston Fire Department and the Department of Health and Hospitals have been meeting with representatives from the Office of the Chief Operating Officer, City Hall. With the assistance of a mediator, they have been working to clarify and coordinate a number of issues. These meetings have covered a number of topics, including dispatch, nature codes, quality assurance and training. Though we all know that there are rumors about a possible merger of the two services, the meetings have not addressed this topic.

In the meantime, while these meetings are going on and while speculation of a merger continue to circulate, it is essential that we continue to provide Boston residents with the highest level of emergency medical services possible.

I am proud of the many accomplishments that we as a department have achieved and I am confident that each of you will continue to provide the highest level of quality service that has made this department one of the finest in the country.

BOARD OF MERIT

The Board of Merit, consisting of the Fire Commissioner and the Deputy Fire Chiefs, has considered all meritorious acts referred to it during the year 1994. After careful consideration and study, the Board submitted the following recommendations which are hereby approved by the Fire Commissioner:

1. Case of Fire Fighter Don F. Cuddahy, Tower Company

On February 3, 1994, at 0408 hours, Incident #5003, Box 1372 was struck for a building fire at 63 Hancock Street, Beacon Hill. Heavy smoke was reported by first arriving companies who rescued people from the front windows and balconies.

Screams for assistance were heard from the rear of the building. A woman had climbed upon the rail of the fifth floor balcony, with her back against the wall. The entire area was blocked by snow banks and all the alleyways were impassable. An attempt to run a ground ladder through the front door and out the rear of an adjacent building proved futile. During this time, fire fighters in the rear assured the woman she would be rescued and not to jump. Fire was now extending out the third and fourth floor windows below her.

Engine Company 4 had run a line up the front stairwell to the third floor landing where they were able to knock down the fire in the stairwell and keep the remaining fire from re-entering it. Fire Fighter Don F. Cuddahy of the Tower Company went up the stairs, past Engine Company 4. He went to the fifth floor, made his way to a rear apartment and out on the balcony. He located the woman and lifted her up to Fire Fighter Thomas Bell of Ladder Company 17 who had ascended to the roof. Fire Fighter Bell grabbed her arms and pulled her over the edge of the roof while Fire Fighter Cuddahy pushed her up. Fire Fighter Cuddahy then climbed up on the balcony rail and was pulled up by members of Ladder Company 24. While this rescue was occurring, fire gained control of the fifth floor and was coming out the windows on floors three, four and five. Fire Fighter Cuddahy was transported to Mass. General Hospital where he was treated for burns and heat exhaustion.

Because of his swift life saving actions during serious deteriorating fire conditions and while under great personal risk, the Fire Commissioner highly commended Fire Fighter Don F. Cuddahy of the Tower Company in General Order No. 14 of 1994.

The Board recommends that the name of Fire Fighter Don F. Cuddahy of the Tower Company be placed on the Roll of Merit.

2. Case of Fire Lieutenant Edward J. White, Ladder Company 18

On June 3, 1994, at 2145 hours, Fire Lieutenant Edward J. White of Ladder Company 18 observed an individual outside quarters screaming obscenities and striking signs, buildings, etc. with a fence post. He also had assaulted one person and was terrorizing a group of people with this irrational and aggressive behavior.

Fire Lieutenant Edward J. White ran from the fire house and assisted a police officer in disarming and subduing this person.

Because of his quick action, a violent and explosive situation was quelled before more violent injuries could be sustained. By reflecting credit upon himself and the Boston Fire Department, the Fire Commissioner highly commended Fire Lieutenant Edward J. White of Ladder Company 18 in General Order No. 30 of 1994.

The Board recommends that Fire Lieutenant Edward J. White of Ladder Company 18 be awarded the Distinguished Service Award.

3. Cases of Fire Lieutenant Michael E. Tierney, Ladder Company 15

Fire Fighter Edward C. Doherty, Ladder Company 15

Fire Fighter Brendan Collins, Ladder Company 15

On February 5, 1994, at 0830 hours, Engine Company 33 and Ladder Company 15 responded to the Howard Johnson Hotel at 575 Commonwealth Avenue, District 5, for a report of smoke on the seventh floor. Upon arrival on floor number seven, Fire Lieutenant Michael E. Tierney, Fire Fighters Richard H. Graham, Edward C. Doherty and Brendan Collins of Ladder Company 15, encountered a heavy smoke condition. Approaching the interior smoke doors, the crew encountered a substantial increase in heat, flames were seen beyond that point and screams of residents trapped in their rooms could be heard. The crew, advancing down the hallway through extreme heat, zero visibility and passing fire, split into two teams of two men. Each team forced entry into separate rooms, rescuing victims, where they were subsequently removed to the hospital. The search and rescue operations were performed before hand lines were in place and prior to ventilation.

Because of their life saving actions during serious fire conditions and while under great personal risk, the Fire Commissioner highly commended Fire Lieutenant Michael E. Tierney, Fire Fighters Richard H. Graham, Edward C. Doherty, and Brendan Collins of Ladder Company 15 in General Order No. 33 of 1994.

The Board recommends that the names of

Fire Lieutenant Michael E. Tierney, Ladder Company 15

Fire Fighter Richard H. Graham, Ladder Company 15

Fire Fighter Edward C. Doherty, Ladder Company 15

Fire Fighter Brendan Collins, Ladder Company 15

be placed on the Roll of Merit.

4. Case of Fire Fighter Robert Cox, Ladder Company 29

On June 23, 1994, at 0256 hours, Ladder Company 29 responded to a building fire at 8 Greendale Road, District 12. Upon arrival, Fire Fighter Robert Cox of Ladder Company 29 was informed that a child was trapped on the second floor. Heavy fire engulfed the entire third floor and had dropped to the second floor which had a heavy smoke condition.

Fire Fighter Cox began his search at the front of the apartment on the second floor, proceeded down the hallway to a rear bedroom where he found an eight year old child in a top bunk with fire surrounding her. He carried the child through the heavy smoke, down the stairs to safety.

Because this rescue was performed under great personal risk before the placing of lines of hose and ventilation, the Fire Commissioner highly commended Fire Fighter Robert Cox of Ladder Company 29 in General Order No. 35 of 1994.

The Board recommends that the name of Fire Fighter Robert Cox be placed on the Roll of Merit.

5. Case of Fire Captain Joseph I. Holland, Engine Company 2

On March 27, 1994, at approximately 0400 hours, Engine Company 2 and Ladder Company 19 returned to quarters from a false alarm. Upon reaching the second floor hallway of the firehouse, Captain Joseph I. Holland of Engine Company 2 was confronted by two individuals who had entered the firehouse during the absence of the companies. One of the individuals put two handguns to Captain Holland's head and began making irrational demands including bringing certain on duty members to the second floor location. At this point he removed the guns momentarily and Captain Holland seized the man's wrists and pinned him against the wall. In doing so, the man's jacket opened revealing two more handguns in his waistline. While keeping a vigilant eye on the second person, Captain Holland continued to restrain the armed man, saying he would release him if he calmed down. The second individual at this time walked down the stairs and out of the firehouse.

After agreeing to calm down, Captain Holland released his grip and the armed man again pointed the guns to the Captain's head, demanding that he call the Mayor. Captain Holland called the Fire Alarm Office pretending to be talking to the Mayor's Office. The irrational behavior escalated to where he again demanded certain members be brought to him. Captain Holland refused to do so. After an extended period of time the armed man asked about the Mayor's response and being infuriated fired a shot at Captain Holland missing his head by inches. He then threw a gun at the Captain, hitting him on the knee. The gun landed on the floor between Captain Holland's legs.

He then demanded Captain Holland pick it up. The Captain refused, telling him he did not use or approve of guns. After another extended period of time the armed man sat on the floor in a corner and continuing to point the guns at Captain Holland, told him to leave and close the door behind him. Captain Holland, at this time, walked out of the room and, after ordering all members out of the building, exited the firehouse. Because of his composure during this volatile incident, Fire Captain Holland most certainly prevented the injury or death to all members working on that tour of duty.

Because of his life saving actions, under extreme personal risk, the Fire Commissioner highly commended Fire Captain Joseph I. Holland of Engine Company 2 in General Order No. 38 of 1994.

The Board recommends that Fire Captain Joseph I. Holland of Engine Company 2 be awarded the Distinguished Service Award.

6. Case of Acting Fire Lieutenant Michael E. Hocking
Engine Company 4 (Detailed to Engine Company 37)

On December 6, 1994, at 0544 hours, Incident #52807, Box 2266 was struck for a building fire at 133 Thornton Street, Roxbury. Heavy fire was reported showing from the first floor of a three story wood frame tenement by the first arriving companies. Engine Company 42 and Rescue Company 2 ran a 2 1/2" line and attempted to gain entry to the first floor front. At this time, the incident commander was informed that a five year old boy was missing and still inside the first floor apartment. Engine Company 37 and Ladder Company 26 were ordered to conduct a search and rescue effort from the rear of the building. Acting Fire Lieutenant Michael E. Hocking, Engine Company 4 (detailed to Engine Company 37) and his crew entered the first floor hallway. Encountering extreme heat and heavy smoke, with fire extending down the hallway toward him, Acting Lieutenant Hocking crawled down the hallway, continually being hung up by debris and other obstacles. Under rapidly deteriorating conditions, Acting Lieutenant Hocking located the child on a bedroom floor, removed his face piece and placed it on the child as he made his way out of the apartment, encountering the same obstacles that hindered his way into the apartment.

Because his actions were performed before adequate ventilation could be made to metal grated windows and without benefit of a charged line, and under extreme personal risk, the Fire Commissioner highly commended Acting Fire Lieutenant Michael E. Hocking of Engine Company 4 (detailed to Engine Company 37) in General Order No. 41 of 1994.

The Board recommends that Acting Fire Lieutenant Michael E. Hocking, Engine Company 4, detailed to Engine Company 37, be awarded the Walter Scott Medal for Valor.

7. Cases of Fire Fighter Thomas C. White, Engine Company 8
Fire Fighter William J. Blackstone, Ladder Company 1

On November 4, 1994, Fire Fighter Thomas C. White, Engine Company 8 and Fire Fighter William J. Blackstone, Ladder Company 1, were working a paid detail at 51 Blossom Street, District 3. At approximately 1335 hours, Fire Fighter Thomas C. White noticed smoke coming from a window of an adjacent building at 33 Blossom Street. He then instructed a Boston police officer to notify the Fire Alarm Office, and he and Fire Fighter William J. Blackstone picked up two extinguishers and proceeded to the fire building. Upon entering the apartment, they found an elderly woman lying semi-conscious on the floor and a sofa fully involved in flames. The fire fighters removed the victim and re-entered the apartment and were able to hold the fire, preventing flashover and undoubtedly saved the woman's life.

Because of their swift actions, under great personal risk, the Fire Commissioner highly commended Fire Fighter Thomas C. White of Engine Company 8 and Fire Fighter William J. Blackstone of Ladder Company 1 in General Order No. 3 of 1995.

The Board recommends that Fire Fighter Thomas C. White of Engine Company 8 and Fire Fighter William J. Blackstone of Ladder Company 1 be awarded the Distinguished Service Award.

8. Case of Fire Fighter Gregory Fall, Ladder Company 14

On December 31, 1994, at 0755 hours, Incident #57020, Box 5127 was struck for a building fire at 13 Pratt Street, Allston. Upon arrival, heavy fire was reported on the first and second floors and a person reportedly was trapped on the third floor. The incident commander ordered Fire Fighter Gregory Fall of Ladder Company 14 to conduct a search of the third floor. Fire Fighter Fall ascended Ladder Company 14's aerial and entered a third floor window, encountering extreme heat and heavy smoke conditions. Crawling around the apartment he came upon a bed and not finding anyone in it, he continued searching around the floor and located an unconscious man next to the bed. Fire Fighter Fall dragged the victim to the window where he was assisted by other members who removed the victim down the aerial ladder to safety.

Because his actions were performed under zero visibility and extreme heat conditions, before adequate ventilation, without benefit of a charged line and under extreme personal risk, the Fire Commissioner highly commended Fire Fighter Gregory Fall of Ladder Company 14 in General Order No. 3 of 1995.

The Board recommends that Fire Fighter Gregory Fall of Ladder Company 14 be awarded the Patrick J. Kennedy Medal of Honor.

9. Case of Fire Lieutenant Stephen F. Minehan, Ladder Company 15

For actions performed under the most severe and difficult fire conditions on June 24, 1994, at a warehouse and pier fire which resulted in his untimely line of duty death, while attempting the rescue of two critically injured fire fighters, the Board recommends that the John E. Fitzgerald Medal for the Most Meritorious Act be awarded posthumously to Fire Lieutenant Stephen F. Minehan, a member of Ladder Company 15.

FIRE PREVENTION WEEK

Fire Prevention Week will be observed in the City of Boston from October 8 to October 14, 1995, inclusive.

During Fire Prevention Week, company officers and all members shall review the smoke detector laws so that people visiting the firehouses can get the correct answers to smoke detector laws.

It is the responsibility of company officers to see to it that these signs are kept in good condition from year to year. Signs should be displayed from Sunday to Saturday. Signs shall be checked daily by the officer in charge of quarters to assure that they are firmly affixed to the building in a proper manner.

District Fire Chiefs are directed to take an active interest in Fire Prevention Programs in the following manner:

By making arrangements with the various plants and industrial enterprises within the district to hold fire drills during the week, by grading these drills as good, fair, or poor and making a report of same to the Fire Prevention Division, indicating the name of the enterprise, the date of the drill and the grade. Same should be forwarded promptly. Each concern should be requested to acknowledge participation in Fire Prevention Week activities via written correspondence. These drills should be conducted by a company officer after arrangements are made. At plants where there are special or company fire brigades, particular attention should be given to assignments and/or response procedures. It is requested that the name of the company officer conducting the drill be furnished. It is anticipated that not less than three drills be conducted in each district.

Company officers will contact school officials in the schools in their sub-district and make arrangements to hold the required fire exit drills during Fire Prevention Week. The fire exit drill shall be so arranged that it will be held prior to the end of the school day.

The District Fire Chief should compile a list of fraternal, social, civic and professional organizations within the district and convey to them the willingness of the fire department to provide company officers for the purpose of lecturing on fire prevention at any time. District Fire Chiefs should make a concerted effort to bring the activities of the department before these organizations and arrange for lectures to be given. The name of any organization so participating should be reported to the Fire Prevention Division, specifically if the organization can be urged to forward on their own stationery a notation of the event, it would be to the greater advantage of the fire department.

Firefighters are to pay special attention to the observance of fire hazards and to the duty of observing and locating fire hazards along the route followed by them in their coming to and going from daily work. All buildings being erected, demolished or significantly remodeled require permits, as do storage and use of flammable gases. Notify your District Chief and/or Fire Prevention Division at extension 3620. Dilapidated buildings, rubbish accumulation and other hazards should be reported in accordance with abatement procedures as outlined in S.O.P. 25. The public expects uniformed members of the fire department to know something about fire prevention work and to have an interest in this subject since they are public employees engaged in this field. Firefighters, therefore, during Fire Prevention Week, should have this subject uppermost in their minds and they should not pass a fire hazard at any time without making a note of it for reference to the Fire Prevention Division. In short, every uniformed member in the fire department is a fire prevention inspector at all times.

Company commanders, on receipt of the Fire Prevention Posters, will post these items in a suitable location at the front of each fire station where they will be visible to the public. They will remain posted through October 14, 1995.

A list of all fire prevention activities and their locations will be forthcoming.

Sirens shall be sounded for 10 seconds.

Members are encouraged to proclaim October 15th "Fallen Firefighters Memorial Day" and observe a special moment of silence for Fire Lieutenant Stephen F. Minehan, Ladder Company 15, who died in the performance of his duties on June 24, 1994.
