I. COMMISSIONER'S UNIT CITATION

On the morning of December 11, 1998, Box 6311 was struck for a fire in the 9 ½ mile Outfall Tunnel at the Deer Island Sewerage Treatment Plant. Upon arrival of the department smoke was showing from the shaft. Project personnel advised the Boston Fire Department that all personnel were out of the tunnel, that no one was in the tunnel when the fire broke out (during shift changes) and they had no idea what was burning. The Boston Fire Department Incident Commander followed Tunnel Mask Incident procedure. Extensive consultations with project engineers were conducted and gas readings were taken. It was determined that the fire should be within 3500' of the shaft. The air supply to the tunnel was shut down in an attempt to allow the fire to self-extinguish. After two hours, the air supply system was reactivated and a light volume of smoke again began to emerge from the shaft. At that time the Boston Fire Department Incident Commander determined that an exploratory entry would be made.

Two tunnel trained entry teams were assembled to enter the tunnel in an attempt to locate the fire. Tunnel Entry Team 1, equipped in accordance with Tunnel Mask Incident S. O. P. # 57, the Cairns Iris and fire extinguishers, descended the 400' shaft and with a Tunnel Mask trained "Loc" operator, proceeded out into the tunnel. There was zero visibility at the base of the shaft and out into the tunnel. The team went to the end of the rail system approximately 1500', and then proceeded another 30' by foot in knee deep mud in an attempt to locate the fire. At that point an infrared scan by the Iris was done for another 150' with negative signs of fire. At that point, the entry team leader, Lieutenant John O'Brien, determined that they had reached their limit and ordered the team to exit the tunnel.

Tunnel Entry Team 1 operated under difficult conditions with an unknown fire burning, a high concentration of smoke and no visibility. They had to rely solely on their training, equipment, experience, self discipline, leadership and one another. They performed this mission in an exemplary manner pushing themselves to the very limit of their training, equipment, and personal stamina. Their commitment and courage in this operation were obvious to all in attendance.

**INVESTIGATION & ORDERS UNDER GENERAL LAWS
CHAPTER 148, SECTIONS 4 & 5**

Pursuant to and in the exercise of the power invested in me under the provisions of General Laws, Deputy Fire Chiefs, District Fire Chiefs, Fire Captains, Fire Lieutenants, Fire Fighter Inspectors of the Fire Prevention Division, Fire Fighters in the Fire Fighting Force, Fire Department Chemist, Fire Department Plans Examiners, Special Hazard Police Officer, Fire Investigation Police Officers, Superintendent of the Emergency Management Division, and those designated by him as Inspectors of Fire Alarm Systems, are authorized to do and perform all and singular the acts and things which I, as Head of the Fire Department, by said Chapter 148, Sections 4 & 5, am empowered to do and perform. Specific authority is hereby delegated to the said Deputy Fire Chiefs, District Fire Chiefs, Fire Captains, Fire Lieutenants, Fire Fighter Inspectors of the Fire Prevention Division, Fire Fighters in the Fire Fighting Force, Fire Department Chemist, Fire Department Plans Examiners, Special Hazard Police Officer, Fire Investigation Police Officers, Superintendent of the Emergency Management Division, those designated by him as Inspectors of Fire Alarm Systems and Fire Department Inspectors of the Special Projects Division, to make investigations and inspections and to issue orders in writing pursuant to the provisions of said actions.

The above delegations of authority, effective as of January 31, 1999, shall continue in force and effect for a period of one year from the effective date, unless revoked at any time prior thereto. The above delegations of authority are not to diminish nor curtail any of the powers conferred upon me by said General Laws, Chapter 148, Sections 4 & 5.

IV. COMMISSIONER'S UNIT CITATION

On January 5, 1999, at 1110 hours, Box 529 was struck for a building fire at North Beacon and Gordon Streets in District 11.

Ladder Company 26, responding from the quarters of Ladder Company 14, reported heavy smoke from a 2 ½ story wood framed dwelling upon arrival. At this time they were notified by the Boston Police that occupants were trapped on the second floor. Fire Lieutenant Emmet P. Nichols, Jr. observed a male occupant at a second floor window threatening to jump. He ordered the aerial ladder raised to the occupant's position as well as a ground ladder. He and Fire Fighter Joseph Capobianco entered the house and began a primary search of the second floor. They found the semi-conscious man in the rear of the apartment. They brought him to a front window where he was placed on the aerial ladder, removed to the street, and was taken to Saint Elizabeth's Hospital by Boston EMS suffering from smoke inhalation.

BOARD OF MERIT

The Board of Merit, consisting of the Fire Commissioner and the Deputy Fire Chiefs, has considered all meritorious acts referred to it during the year 1998. After careful consideration and study, the Board submitted the following recommendations which are hereby approved by the Fire Commissioner:

**1. Gerard J. Molito Award for Professional Excellence
Fire Captain Terence A. Koen, Engine Company 33**

Fire Captain Terence A. Koen has demonstrated professionalism, dedication and enthusiasm in many areas which have been of great benefit to Boston Fire Fighters and improved the delivery of services to the people of Boston.

He has used his expertise in Hazardous Materials and Decontamination Procedures to train members of the department. As a member of the Communications Committee he has used his technical knowledge to improve communications and to test and develop systems for containment suits and fire apparatus.

His enthusiasm, love of the fire department and his attention to detail creates a very effective learning environment and the training of members has become an enjoyable and positive experience.

The Board recommends that Fire Captain Terence A. Koen of Engine Company 33 be awarded the Gerard J. Molito Award for Professional Excellence.

2. Case of Fire Captain William J. Meyer, Personnel Division

On March 16, 1998, at BankBoston, 100 Federal Street, Boston, a male suspect stole money from a female customer. A male customer attempted to stop the fleeing suspect but was overpowered. While off duty and present as a customer in the bank, upon being informed of this incident, he ran outside in pursuit, tackled the suspect and restrained him until the arrival of bank security guards and the Boston Police.

Because his actions were performed at great personal risk, the Fire Commissioner highly commended Fire Captain William J. Meyer of the Personnel Division in General Order No. 14 of 1998.

The Board recommends that Fire Captain William J. Meyer of the Personnel Division be awarded the Distinguished Service Award.

3. Case of Fire Lieutenant Leo K. Mahoney, Ladder Co. 19

On May 11, 1998, Engine Company 2 responded to 845 East Fifth Street, South Boston, for a cardiac arrest. Upon arrival they found him performing CPR on Fire Fighter Garrett M. Stapleton of the Fire Brigade. He had been informed by the daughters of Fire Fighter Stapleton of their father's condition. He responded upstairs and began this life saving procedure. At this point, Engine Company 2 hooked up their defibrillator and applied one shock. Boston EMS arrived and applied two additional shocks.

Because of his quick response and efforts to revive Fire Fighter Stapleton, they were able to get a pulse and restore his breathing. The Fire Commissioner highly commended Fire Lieutenant Leo K. Mahoney of Ladder Company 19 in General Order No. 19 of 1998.

The Board recommends that Fire Lieutenant Leo K. Mahoney of Ladder Company 19 be awarded the Distinguished Service Award.

4. Case of Fire Captain Peter P. Pearson, Ladder Company 24

On June 2, 1998, while off duty and visiting at a friend's home, he was alerted by a neighbor that there was a fire in the neighbor's house. He ran to the house where he found a garden hose in the back yard. He entered the home into the heavy smoke filled family room where he was able to locate and extinguish the fire without the benefit of protective clothing and before ventilation could be performed.

Because his actions were performed at great personal risk, the Fire Commissioner highly commended Fire Captain Peter P. Pearson of Ladder Company 24 in General Order No. 20 of 1998.

The Board recommends that Fire Captain Peter P. Pearson of Ladder Company 24 be awarded the Distinguished Service Award.

5. Case of Fire Fighter Kenneth Jones, Engine Company 39

On May 20, 1998, he was summoned from a paid detail in the area to assist a person who had collapsed at the Chart House Restaurant, on Long Wharf, Boston. He found an elderly woman on the second floor in cardiac arrest. He initiated CPR and continued unassisted until the arrival of apparatus and then assisted with defibrillation procedures.

Because of his dedicated actions, this woman can be counted as a survivor and the Fire Commissioner highly commended Fire Fighter Kenneth Jones of Engine Company 39 in General Order No. 20 of 1998.

The Board recommends that Fire Fighter Kenneth Jones of Engine Company 39 be awarded the Distinguished Service Award.

6. Case of Fire Lieutenant Robert B. Kerrigan, Engine Company 8

On October 13, 1998, while off duty and shopping at the Home Depot in Rockland, he went to the aid of a retired 64 year old Weymouth Police Officer who had collapsed nearby. His initial survey revealed no pulse and no breathing. He immediately began CPR until the arrival of the Rockland Fire Department and continued until they successfully defibrillated the man.

Because of his actions the man has since had cardiac surgery and has made a complete recovery, and the Fire Commissioner highly commended Fire Lieutenant Robert B. Kerrigan of Engine Company 8 in General Order No. 5 of 1999.

The Board recommends that Fire Lieutenant Robert B. Kerrigan of Engine Company 8 be awarded the Distinguished Service Award.

7. Case of Fire Fighter George S. Thibodeaux, Engine Company 4

On May 27, 1998, at 1645 hours, Box 3115 was struck for a building fire at 24 Hamilton Street, Dorchester. While off duty and before the arrival of apparatus, under heavy smoke and fire conditions, he entered the fire building and assisted several occupants to safety. This fire went to three alarms and damaged five buildings.

Because these actions were performed at great personal risk, the Fire Commissioner highly commended Fire Fighter George S. Thibodeaux of Engine Company 4 in General Order No. 24 of 1998.

The Board recommends that the name of Fire Fighter George S. Thibodeaux of Engine Company 4 be placed on the Roll of Merit.

8. Case of Fire Fighter John F. Linnell, Ladder Company 17

On July 15, 1998, at a building fire at 40 Dwight Street, South End, while performing roof ventilation, he was alerted that a woman was trapped on the third floor. He slid down the mansard part of the roof to the third floor ledge where he broke a window to gain entry. He entered the room which was charged with heavy smoke and found the unconscious woman on the floor. He carried her to the window, where assisted by another fire fighter, they removed her to the street.

Because these actions were performed at great personal risk, the Fire Commissioner highly commended Fire Fighter John F. Linnell of Ladder Company 17 in General Order No. 26 of 1998.

The Board recommends that the name of Fire Fighter John F. Linnell of Ladder Company 17 be placed on the Roll of Merit.

9. Case of Fire Fighter Francis G. Clines, Ladder Company 24

On July 15, 1998, at a building fire at 40 Dwight Street, South End, while ascending the aerial ladder to assist in roof ventilation, he observed a woman trapped inside the third floor. He climbed off the ladder and onto the third floor ledge where he was assisted by another fire fighter. They entered the smoke filled room and lifted the unconscious woman out of the room to the ledge where she was carried down to safety.

Because these actions were performed at great personal risk, the Fire Commissioner highly commended Fire Fighter Francis G. Clines of Ladder Company 24 in General Order No. 26 of 1998.

The Board recommends that the name of Fire Fighter Francis G. Clines of Ladder Company 24 be placed on the Roll of Merit.

10. Case of Fire Lieutenant Richard M. Quinlan, Ladder Company 17

On July 15, 1998, at a building fire at 40 Dwight Street, South End, a large volume of fire erupted from the first floor and at the same time a man appeared at a third floor window unable to escape. He ascended a ground ladder above this heavy fire to effect the rescue of this man who was now hanging onto the window ledge and about to drop to the ground. He was able to reach over and grab the man from the ledge, placed him on the ladder and guided him down to the street.

Because these actions were performed at great personal risk, the Fire Commissioner highly commended Fire Lieutenant Richard M. Quinlan of Ladder Company 17 in General Order No. 26 of 1998.

The Board recommends that the name of Fire Lieutenant Richard M. Quinlan of Ladder Company 17 be placed on the Roll of Merit.

11. Case of Fire Fighter Kevin G. Mitchell, Ladder Company 17

On August 7, 1998, at a building fire at 536 Commonwealth Avenue, Kenmore Square, as he ascended the aerial ladder he observed a woman in a fourth floor window engulfed in heavy smoke. As he was taking her on the aerial ladder, fire broke out from windows directly below them. He put her back through the window and led her to an interior stairway. Unable to use the stairway because of heat and a heavy smoke condition, they returned to the window where the heavy fire below them was knocked down. He then placed her on the aerial ladder and guided her safely to the ground.

Because these actions were performed at great personal risk, the Fire Commissioner highly commended Fire Fighter Kevin G. Mitchell of Ladder Company 17 in General Order No. 41 of 1998.

The Board recommends that the name of Fire Fighter Kevin G. Mitchell of Ladder Company 17 be placed on the Roll of Merit.

12. Case of Fire Fighter Thomas Flynn, Ladder Company 24

On October 17, 1998, on the Charles River, Back Bay, he donned a flotation suit and swam 400 feet to an unconscious woman who was floating under the Longfellow Bridge. He was transported to the hospital and treated for the effects of the cold water and exhaustion.

Because these actions were performed at great personal risk, the Fire Commissioner highly commended Fire Fighter Thomas Flynn of Ladder Company 24 in General Order No. 41 of 1998.

The Board recommends that the name of Fire Fighter Thomas Flynn of Ladder Company 24 be placed on the Roll of Merit.

13. Case of Fire Fighter Edward T. Loder, Rescue Company 1

On October 17, 1998, on the Charles River, Back Bay, he donned a flotation suit and swam 400 feet to an unconscious woman who was floating under the Longfellow Bridge. With difficulty and the assistance of Fire Fighter Thomas Flynn, they placed her in a boat and performed CPR. He was transported to the hospital and treated for the effects of the cold water and exhaustion.

Because these actions were performed at great personal risk, the Fire Commissioner highly commended Fire Fighter Edward T. Loder of Rescue Company 1 in General Order No. 41 of 1998.

**14. Case of Fire Fighter Eugene B. Fortes, Engine Company 51
(Detailed to Ladder Company 11)**

On April 30, 1998, at a building fire at 14 Colbourne Road, Brighton, he observed heavy smoke pushing from an apartment door on the third floor. He made forced entry and assisted in removing a man from the floor. Shortly after closing the apartment door, the room flashed over. This rescue was performed prior to ventilation and without the protection of a charged line.

Because these actions were performed at great personal risk, the Fire Commissioner highly commended Fire Fighter Eugene B. Fortes of Engine Company 51, detailed to Ladder Company 11, in General Order No. 19 of 1998.

The Board recommends that the name of Fire Fighter Eugene B. Fortes of Engine Company 51, detailed to Ladder Company 11, be placed on the Roll of Merit.

15. Case of Fire Lieutenant Robert J. Connolly, Ladder Co. 11

On April 30, 1998, upon arrival at a building fire at 14 Colbourne Road, Brighton, he was informed of a man trapped in an apartment that was on fire. He ordered forced entry to the third floor apartment door and was able to open it enough to squeeze through. Upon entering the room he had to drop to the floor because of extreme heat and smoke. The trapped man's body was wedged against the door. In order to remove him, he closed the door behind him and moved the man away from the doorway. Once this was done, he reopened the door and was assisted by another firefighter in removing the man to the hallway. Shortly after he closed the apartment door the room flashed over.

Because these actions were performed at extreme personal risk, the Fire Commissioner highly commended Fire Lieutenant Robert J. Connolly of Ladder Company 11 in General Order No. 19 of 1998.

The Board recommends that Fire Lieutenant Robert J. Connolly of Ladder Company 11 be awarded the John E. Fitzgerald Medal for the Most Meritorious Act.

VIII. HIGH COMMENDATION

On April 7, 1999, while working a paid detail in District 4, Fire Fighter James K. Cheatham was notified of an automobile accident in that vicinity. He approached a vehicle and observed an unconscious person inside. He immediately performed a primary medical survey and discovered the man did not have a pulse. He notified Fire Alarm by radio to send emergency units to the scene. He then began CPR and was assisted by a nurse from Boston Medical Center. They continued CPR until the arrival of apparatus. Fire Fighter Cheatham assisted in placing the defibrillator on the patient. They shocked the patient twice and were able to establish a pulse. EMS arrived and transported the man to the hospital.

Because his actions undoubtedly saved the man's life, the Fire Commissioner is pleased to highly commend Fire Fighter James K. Cheatham of Ladder Company 17, and refers his case to the Board of Merit for further consideration.

IX. COMMISSIONER'S UNIT CITATION

On the morning of January 7, 1999, Engine Company 7 and Ladder Company 15 responded to an automobile accident at 257 Stuart Street.

Upon arrival they found an elderly woman was pinned beneath the rear dual wheels of a dumpster removal truck. The members immediately assisted Boston EMS with stabilizing the victim and also provided care to the truck driver after he observed what had happened.

District 4 and Rescue Company 1 arrived and District 4 ordered the Collapse Unit to the scene. The members of Rescue Company 1, assisted by members of Engine Company 7 and Ladder Company 15, placed a 25 ton jack under the rear axle and two (2) 70 ton air bags under the truck's frame in front of the wheels. The surgeon on scene then gave word to start the jacking operation. This operation lifted the tires off the woman's legs and she was extricated. After this operation was completed, G-25 along with H-3 and members of Engine Company 7 and Ladder Company 15, started decon operations on members who were exposed to possible bio-hazards and the clean up of the surrounding area.

I. FIRE PREVENTION WEEK

Fire Prevention Week will be observed in the City of Boston from October 3 to October 9, 1999, inclusive.

During Fire Prevention Week, company officers and all members shall review the smoke detector laws so that people visiting the firehouses can get the correct answers to their questions on smoke detectors.

Fire stations shall be open to the public between the hours of 1200 and 1700 hours for visits of the premises and for the conveyance of information concerning the fire department functions and fire prevention matters. When citizens come to a station during Fire Prevention Week, the member on house patrol shall summon the commanding officer who should be available to show the visitors around the station and to answer the questions regarding the department, or to have a suitable person assigned to this duty.

The officer in charge of quarters shall see that the Fire Prevention banners being issued to all stations are displayed for the entire month of October. Banners shall be checked daily by the officer in charge of quarters to assure that they are firmly affixed to the building in a proper manner. The banners will be collected at the end of the month to be stored at Headquarters.

District Fire Chiefs are directed to take an active interest in Fire Prevention Programs in the following manner:

By making arrangements with the various plants and industrial enterprises within the district to hold fire drills during the week, by grading these drills as good, fair, or poor and making a report of same to the Fire Prevention Division, indicating the name of the enterprise, the date of the drill and the grade. Same should be forwarded promptly. Each business should be requested to acknowledge participation in Fire Prevention Week activities via written correspondence. These drills should be conducted by a company officer after arrangements are made. At plants where there are special or company fire brigades, particular attention should be given to assignments and/or response procedures. It is requested that the name of the company officer conducting the drill be furnished. It is anticipated that not less than three drills be conducted in each district.

Company officers shall contact school officials in the schools in their sub-district and make arrangements to hold the required fire exit drills during Fire Prevention Week. The fire exit drill shall be so arranged that it will be held prior to the end of the school day. The District Fire Chief should compile a list of fraternal, social, civic and professional organizations within the district and convey to them the willingness of the fire department to provide company officers for the purpose of lecturing on fire prevention at any time.

District Fire Chiefs should make a concerted effort to bring the activities of the department before these organizations and arrange for lectures to be given. The name of any organization so participating should be reported to the Fire Prevention Division, specifically if the organization can be urged to forward on their own stationery a notation of the event, it would be to the greater advantage of the fire department.

Firefighters are to pay special attention to the observance of fire hazards and to the duty of observing and locating fire hazards along the route followed by them in their coming to and

going from daily work. All buildings being erected, demolished or significantly remodeled require permits, as do storage and use of flammable gases. Notify your District Fire Chief and/or Fire Prevention Division at extension 3620. Dilapidated buildings, rubbish accumulation and the other hazards should be reported in accordance with abatement procedures as outlined in S. O. P. # 25. The public expects uniformed members of the fire department to know something about fire prevention work and to have an interest in this subject since they are public employees engaged in this field. Firefighters, therefore, during Fire Prevention Week, should have this subject uppermost in their minds and they should not pass a fire hazard at any time without making a note of it for reference to the Fire Prevention Division. In short, every uniformed member in the fire department is a fire prevention inspector at all times.

I. HEALTH AND FITNESS PROGRAM

This has been a very tragic year for the members and families of the Boston Fire Department with ten active members dying, nine of who died from a heart attack or cancer. I cannot stress enough the importance of having yearly physicals and participation in a routine exercise program. It is our goal to reduce the number of firefighter deaths given the extraordinary risks, exposures and stresses associated with firefighting.

The department has begun to work closely with the efforts of Local 718's Wellness Committee in establishing a comprehensive firefighter health and fitness program. The main goal of this program is to improve the health and fitness of our firefighters in order to prevent any more untimely and tragic deaths. Similar programs have been well received in ten major U. S. fire departments. They are non-punitive and medical records are kept confidential. The input and enthusiasm from all our members will be necessary in order for this program to be implemented and successful.

However, until this program is initiated, I am urging all firefighters to schedule a complete physical and to begin a regular exercise program. Firefighters have a two to three times higher risk of having a heart attack or developing cancer than does any other occupation. For this reason, earlier screenings and a more involved exam should be performed. The following is a list of suggested areas for your primary care physicians' focus.

1.) Areas for screening and specific risk factors for heart disease to be addressed include:

Diabetes	Smoking
Hypertension	Alcohol and Substance Abuse
Obesity	Family History of CAD
Sedentary Lifestyle	High Cholesterol

2.) The annual exam should also include:

Blood Pressure: pulse, respiratory rate, temp and pulse ox
Thorough skin exam
Eye exam, hearing testing

Oral exam
Heart and Lung exam
Abdominal and testicular exam
Prostate and rectal exam with fecal occult blood testing
Vascular, neurological and mental status exam

3.) Necessary lab tests include:

Serum chemistry and liver function test
Complete blood count
Fasting cholesterol and blood glucose
Pulmonary function testing
Chest x-ray every three years
PSA test yearly (beginning age 40 to screen for prostate cancer)
Flexible sigmoidoscopy or colonoscopy (beginning age 40 and every 3 years to screen for colon cancer)
Exercise stress test (beginning age 45 or sooner if any suspicion of coronary artery disease)
Yearly PAP smears and mammograms (for female firefighters)

Regarding the exercise regimen, the Boston Fire Department is purchasing cross-trainer machines for each firehouse and Fire Alarm. Upon a successful physical evaluation, regular use of these machines will greatly improve and maintain the cardiovascular conditioning of our members.

Boston firefighters deserve to live longer and healthier lives and enjoy more time with their families and co-workers. We must begin to take our health more seriously and work together to implement a health and fitness program to prevent even more tragic firefighter deaths.
