III. HIGH COMMENDATION

On June 28, 2003, at 0251 hours, Box 2245 was struck for a building fire at 22 Anita Terrace in District 5. Upon arrival, smoke and fire were issuing from the first floor of the building. Members were informed of a woman who was located inside the building on the first floor, in the room that was fully involved in fire.

Fire Fighter Brian M. Sellon, Ladder Company 4, and Fire Fighter Michael D. O'Reilly, Engine Company 14 (detailed to Ladder Company 4), encountered heavy smoke and intense heat upon entering the apartment. As they searched and ventilated the first floor they located the unconscious victim behind her overturned wheelchair.

Fire Fighter O'Reilly immediately placed his facepiece on the woman, and he and Fire Fighter Sellon proceeded to remove the victim whose extrication, due to her size and position, was quite difficult. The victim was successfully resuscitated and transported to Brigham and Women's Hospital.

Because this rescue was performed at great personal risk, under intense smoke and heat conditions, and without proper ventilation or the benefit of a charged line, the Fire Commissioner/Chief of Department is pleased to highly commend Fire Fighter Brian M. Sellon of Ladder Company 4, and Fire Fighter Michael D. O'Reilly of Engine Company 14 (detailed to Ladder Company 4), and refers their case to the Board of Merit for further consideration.

IV. COMMENDATION

The Fire Commissioner/Chief of Department is pleased to commend Fire Fighter Jose Cancel of Engine Company 22, who while off duty, responded to the aid of a woman who had collapsed at Logan Airport. He led the attempted resuscitation effort for this woman until the arrival of EMS. While no one was able to revive the victim, Fire Fighter Cancel stayed with the family and provided comfort and support to them, missing his own flight in the process. In the words of a grateful family member, "Not only is this man extremely well trained to handle a medical emergency, his response indicated a level of maturity, understanding, and compassion well beyond his years". This commendation shall be made part of his personnel file.

Specific authority is hereby delegated to the said Chiefs of Operations, Deputy Fire Chiefs, District Fire Chiefs, Fire Captains, Fire Lieutenants, Fire Fighter Inspectors of the Fire Prevention Division, Fire Fighters in the Fire Fighting Force, Fire Department Chemist, Fire Department Plans Examiners, Fire Investigation Police Officers, Superintendent of the Fire Alarm Section of the Emergency Management Division, those designated by him as Inspectors of Fire Alarm Systems and Fire Department Inspectors of the Special Projects Division, to make investigations and inspections and to issue orders in writing pursuant to the provisions of said actions.

The Fire Alarm Office shall dispatch the two nearest engine companies, the nearest ladder company and the District Chief of the affected district. The dispatch of the companies shall be announced on channel one.

Upon verification from responding companies, receipt of additional call(s), or if the Principal Operator has reason to believe that there may be a serious fire in progress, the nearest box shall be struck.

V. COMMENDATION

The Fire Commissioner/Chief of Department is pleased to commend Fire Fighter Thomas M. Goggin of Engine Company 50, who while off duty at his home, was alerted by neighbors of a fire at 7 Mystic Place in Charlestown. Fire Fighter Goggin contacted Fire Alarm and was informed that Box 4164 had already been transmitted for this incident. He then proceeded to the fire building and alerted the occupants of the situation. Despite a moderate smoke condition and arching electrical equipment, Fire Fighter Goggin extended his search to the basement. After determining that all of the occupants were out of the building, he contacted Fire Alarm and updated them on the location and severity of the fire. He then met arriving companies, updated the Incident Commander, and assisted in running lines. Fire Fighter Goggin jeopardized his own safety by conducting these actions without the benefit of Personal Protective Equipment or SCBA. This commendation shall be made part of his personnel file.

I. COMMISSIONER'S UNIT CITATION

On Friday, January 23, 2004, the Boston Fire Department Scuba Team was activated at 0425 hours and responded to incident #5794, 123 Saratoga Street, in District 1, for a witnessed report of a woman jumping from the Belle Isle Bridge into the water below. Upon arrival, conditions were extremely poor, with the wind chill factor at ten degrees below zero, ice covered water, difficult access to the ice covered location, and many entanglements under the bridge. Fire Lieutenant Don F. Cuddahy and Fire Fighter Robert J. Doyle immediately geared up, entered the ice-covered water, and proceeded to execute independent search patterns. These members soon developed signs of hypothermia, had to be removed from the water and placed in an ambulance until they could once again open their hands. Their backup safety divers were even colder due to the fact that they were standing-by out in the elements, fully geared up, and ready to respond if needed.

Upon receiving a report of an object being spotted under the ice about two hundred yards out, Boston Fire Department Scuba Team members Assistant Divemaster Patrick F. Foley, Fire Captain John F. Kenney, and Fire Lieutenant Robert F. Santangelo proceeded by boat to a point about thirty feet from the reported location. It was decided to maintain that position for fear of breaking the ice, dislodging the victim, and losing her to the current below. Fire Lieutenant Robert F. Santangelo was then deployed into the water in a dry suit tethered to a safety line. He made his way out over the ice, falling through it several times, finally reaching the victim. He then broke through the ice and was able to grab hold of the victim. While being pulled back to the rescue boat by the safety line, Fire Lieutenant Santangelo had to break the ice with his elbows and still maintain control of the victim.

The extreme elements and many dangers endured by these divers did not prevent them from accomplishing their objective. This recovery, made under the harshest of conditions, exemplifies a dedication to duty consistent with the finest traditions of the Boston Fire Department. I. FR GERARD DEWAN (FDNY) DEDICATION

There will be a flag raising ceremony and dedication held at the quarters of Engine Company 30 and Ladder Company 25, located at 1940 Centre Street, West Roxbury, on Friday, April 16, 2004 at 1330 hours.

This community based and community funded project includes a new flagpole, flag, lighting, landscaping, sprinkler system, granite border and memorial marker located to the left side of the firehouse. The right side of quarters will also be newly landscaped.

This site memorializes Gerard Dewan, a Roslindale native, who pursued his dream of becoming a firefighter by joining the New York City Fire Department (FDNY). When Gerard's dedication to his profession took him into the World Trade Center on September 11, 2001, he, along with 342 of his fellow firefighters, demonstrated the true meaning of courage. Gerard Dewan's line of duty death shall forever be remembered for the lesson it teaches about selfless service to others.

I. COMMENDATIONS

1.) The Fire Commissioner/Chief of Department is pleased to commend Fire Alarm Operator Frank Sullivan of the Fire Alarm Office for securing and coordinating a community based and funded memorial for the late Fire Fighter Gerard Dewan, FDNY. Fire Fighter Dewan's line of duty death, along with 342 of his fellow firefighters at the World Trade Center on September 11, 2001, has demonstrated the true meaning of courage.

This memorial was dedicated on Friday, April 16, 2004, at Engine Company 30 and Ladder Company 25's Quarters, 1940 Centre Street, West Roxbury. The site boasts a new flagpole, flag, lighting, landscaping, granite border and memorial marker to the left side of the firehouse. Through the efforts of Fire Alarm Operator Sullivan, along with those of the committee, this memorial ensures that the sacrifice made by Fire Firefighter Gerard Dewan, FDNY, will never be forgotten. This commendation shall be made part of his personnel file.

2.) The Fire Commissioner/Chief of Department is pleased to commend Fire Lieutenant John Forristall of the Special Operations Command who while off duty, rendered assistance to an accident victim. On April 16, 2004, at 1618 hours, Saugus Ladder 1 responded to a reported MVA at Route 1 North near the Essex Street overpass. Upon arrival they observed Fire Lieutenant Forristall assisting an injured motorcyclist. Despite the very heavy volume of non-stop rush hour traffic, he had crossed three busy lanes of high-speed traffic to assist this man. BOARD OF MERIT

The Board of Merit, consisting of the Fire Commissioner/Chief of Department and the Deputy Fire Chiefs, has considered all meritorious acts referred to it during the year 2003. After careful consideration and study, the Board submitted the following recommendations which are approved by the Fire Commissioner/Chief of Department:

**1. Gerard J. Molito Award
District Fire Chief Curtis Holzendorf of Special Operations Division**

The Boston Fire Department hereby recognizes District Fire Chief Curtis D. Holzendorf of the Special Operations Command for his dedication to improving the capability of this department to respond to incidents involving hazardous materials and technical rescue.

Chief Holzendorf's dedication to training has brought to the Boston Fire Department a measure of professionalism that has never before been achieved by this department in this field. His dedication to training and safety will perpetuate in his training programs and benefit members of the Boston Fire Department for years to come.

Therefore, the Fire Commissioner, acting on the recommendation of the Board of Merit, hereby orders District Fire Chief Curtis D. Holzendorf of the Special Operations be presented the Gerard J. Molito Award.

**2. Case of Fire Fighter Aundria D. Burcy, Engine Company 49
Fire Fighter Cornell Horton, Engine Company 49**

On February 12, 2003, Box 3669, for which two alarms were struck, was transmitted for a building fire at 731 River Street, District 12. Fire Fighter Aundria D. Burcy of Engine Company 49, and Fire Fighter Cornell Horton of Engine Company 49, while off duty, were driving by in separate vehicles when they happened upon the incident.

Heavy fire was visible from the apartment complex. Both members entered the building from the rear and alerted occupants by banging on doors while making their way to the fire floor. During the primary search, Fire Fighter Aundria D. Burcy located two children and removed them to the safety of the street. After completing the primary search, Fire Fighter Cornell Horton reported to the first arriving companies and directed them to the location of the fire.

Because both members performed these actions at great personal risk, without the aid of personal protective equipment or self contained breathing apparatus, and before lines were in place, the Fire Commissioner/Chief of Department highly commended Fire Fighter Aundria D. Burcy of Engine Company 49, and Fire Fighter Cornell Horton of Engine Company 49 in General Order No. 15 of 2003.

Therefore, the Fire Commissioner, acting on the recommendation of the Board of Merit, hereby orders Fire Fighter Aundria D. Burcy of Engine Company 49, and Fire Fighter Cornell Horton of Engine Company 49, be presented the Distinguished Service Award.

3. Case of Fire Fighter Brian D. Burke, Ladder Company 16.

On February 15, 2003, at 2005 hours, Ladder Company 16 responded to a central station alarm at 16 Walk Hill Street in District 12. Upon arrival, Ladder Company 16 observed smoke showing from a first floor apartment.

Fire Fighter Brian D. Burke of Ladder Company 16 entered the building and made his way to the apartment, which was now pushing extremely heavy heat and smoke. The fire was in the kitchen area. The kitchen and living space were incorporated into one large room, it being a studio apartment, and the fire was immediately to his left side as he entered. Fire Fighter Burke proceeded to make a primary search.

During his search he located an unconscious woman on the floor in the rear of the apartment. Fire Fighter Burke was able to lift the victim and remove her to the safety of the street keeping himself between the woman and the fire. He then returned to the apartment and assisted in ventilation and overhaul.

Because this rescue was made during extremely heavy heat and smoke conditions, without the benefit of a charged line or proper ventilation, this member placed himself at great personal risk. The Fire Commissioner/Chief of Department highly commended Fire Fighter Brian D. Burke of Ladder Company 16 in General Order No. 19 of 2003.

The Fire Commissioner, acting on the recommendation of the Board of Merit, hereby orders that the name of Fire Fighter Brian D. Burke of Ladder Company 16 be added to the Roll of Merit.

4. Case of Fire Lieutenant Robert J. Connolly, Ladder Company 11 Fire Fighter Stephen F. Irving, Engine Company 7 (detailed to Ladder Company 11) Fire Fighter Brian Cobb, Ladder Company 14

On March 10, 2003, at 2224 hours, Box 5171 was struck for a building fire at 330 Summit Avenue in District 11. Ladder Company 14 reported smoke showing and upon

his arrival, District 11 observed heavy fire showing from the first floor in the rear of the building extending to the second floor.

Fire Lieutenant Robert J. Connolly of Ladder Company 11, Fire Fighter Stephen F. Irving of Engine Company 7 (detailed to Ladder Company 11), and Fire Fighter Brian Cobb of Ladder Company 14 made their way to the second floor to conduct a search. Because of the heat, heavy smoke and zero visibility, they had to make the search on their hands and knees. While moving down a hallway and sweeping the floor in front of him, Fire Fighter Irving came upon an unconscious female. The victim was wedged between a doorway, making it difficult for him to remove her, and Fire Fighter Irving called out for assistance.

Fire Lieutenant Connolly and Fire Fighter Cobb made their way to the victim and assisted Fire Fighter Irving in removing her to the safety of the street. She was then transported by EMS to the Massachusetts General Hospital suffering from respiratory arrest. She was intubated and subsequently placed into a hyperbaric chamber.

Because this rescue was made under rapidly deteriorating fire conditions, without the benefit of a charged line or proper ventilation, these members placed themselves at great personal risk. The Fire Commissioner/Chief of Department highly commended Fire Lieutenant Robert J. Connolly of Ladder Company 11, Fire Fighter Stephen F. Irving of Engine Company 7 (detailed to Ladder Company 11), and Fire Fighter Brian Cobb of Ladder Company 14 in General Order No. 19 of 2003.

The Fire Commissioner, acting on the recommendation of the Board of Merit, hereby orders that the names of Fire Lieutenant Robert J. Connolly of Ladder Company 11, Fire Fighter Stephen F. Irving of Engine Company 7 (detailed to Ladder Company 11), and Fire Fighter Brian Cobb of Ladder Company 14 be added to the Roll of Merit.

**5. Case of Fire Fighter Brian M. Sellon, Ladder Company 4
Fire Fighter Michael D. O'Reilly, Engine Company 14
(detailed to Ladder Company 4)**

On June 28, 2003, at 0251 hours, Box 2245 was struck for a building fire at 22 Anita Terrace in District 5. Upon arrival, smoke and fire were issuing from the first floor of the building. Members were informed of a woman who was located inside the building on the first floor, in the room that was fully involved in fire.

Fire Fighter Brian M. Sellon, Ladder Company 4, and Fire Fighter Michael D. O'Reilly, Engine Company 14 (detailed to Ladder Company 4), encountered heavy smoke and intense heat upon entering the apartment. As they searched and ventilated the first floor they located the unconscious victim behind her overturned wheelchair.

Fire Fighter O'Reilly immediately placed his facepiece on the woman, and he and Fire Fighter Sellon proceeded to remove the victim whose extrication, due to her size and position, was quite difficult. The victim was successfully resuscitated and transported to Brigham and Women's Hospital.

Because this rescue was performed at great personal risk, under intense smoke and heat conditions, and without proper ventilation or the benefit of a charged line, the Fire Commissioner/Chief of Department highly commended Fire Fighter Brian M. Sellon of Ladder Company 4, and Fire Fighter Michael D. O'Reilly of Engine Company 14 (detailed to Ladder Company 4) in General Order No. 1 of 2004.

The Fire Commissioner, acting on the recommendation of the Board of Merit, hereby orders that the names of Fire Fighter Brian M. Sellon of Ladder Company 4 and Fire Fighter Michael D. O'Reilly of Engine Company 14 (detailed to Ladder Company 4) be added to the Roll of Merit.

6. Case of Fire Fighter Gregory Kelly, Tower Ladder 10

The Fire Commissioner/Chief of Department commended Fire Fighter Gregory Kelly of Tower Ladder 10, who while off duty on October 9, 2003, acted as a first responder. Fire Fighter Kelly was at Engine 10's quarters while the companies were out. A citizen arrived stating that he was having chest pains and needed medical attention. Fire Fighter Kelly immediately notified Fire Alarm, and stabilized the patient until the arrival of EMS. The patient was then transported to the Massachusetts General Hospital where he underwent emergency surgery.

Because of his quick and competent actions, the Fire Commissioner/Chief of Department highly commended Fire Fighter Gregory Kelly of Tower Ladder 10 in General Order No. 38 of 2003.

7. Case of Fire Fighter Vincent E. Dimino, Ladder Company 7

On May 3, 2003, at 0447 hours, Box 3418 was struck for a building fire at 16 Melbourne Street in District 8. Companies were informed while responding, that people were trapped in the building. Upon arrival, heavy fire was showing from a three-story wood frame building. The fire had started on an enclosed porch, broke through an interior window, extended up the stairwell involving the first, second, third floors, and the front porches of the building. The fire was extending to an additional 2½ story wood frame dwelling.

Ladder Company 7, unable to deploy the aerial ladder due to the heavy volume of fire, raised a ground ladder to the third floor window. Fire Fighter Vincent E. Dimino was alerted by a civilian that a man was trapped on the first floor. Fire Fighter Dimino went to the rear of the building and entered the first floor. Through heavy smoke and intense heat he made his way to the front of the building and found an unconscious male on the floor. Carrying the victim back through heavy smoke, Fire Fighter Dimino made his way back to the rear stairs and out to safety. The victim was then transported by EMS to a local hospital and treated.

Because this rescue was performed at extreme personal risk, before proper ventilation had taken place, or without the benefit of a charged line, the Fire Commissioner/Chief of Department highly commended Fire Fighter Vincent E. Dimino of Ladder Company 7 in General Order No. 26 of 2004.

Therefore, the Fire Commissioner, acting on the recommendation of the Board of Merit, hereby orders Fire Fighter Vincent E. Dimino of Ladder Company 7 be presented the Patrick J. Kennedy Medal of Honor.

8. Case of Fire Fighter Dorian Jenkins, Ladder Company 6

On May 3, 2003, at 0447 hours, Box 3418 was struck for a building fire at 16 Melbourne Street in District 8. Companies were informed while responding that people were trapped in the building. Upon arrival, heavy fire was showing from a three-story wood frame building. The fire had started on an enclosed porch, broke through an interior window, extended up the stairwell involving the first, second, third floors, and the front porches of the building. The fire was extending to an additional 2½ story wood frame dwelling.

Ladder Company 6 had raised their aerial ladder to the roof of 18 Melbourne Street, which had become an exposure, due to the heavy volume of fire at 16 Melbourne Street.

Fire Fighter Dorian Jenkins went to the rear of the building where occupants reported to him that people were trapped on the second floor. Fire Fighter Jenkins immediately went to the second floor and through heavy smoke conditions, made his way to the front of the building where he found an unconscious young female. Carrying the victim through heavy smoke, Fire Fighter Jenkins made his way back to the rear stairwell and out to safety. After removing the victim he noticed that she was not breathing and immediately started CPR. He then carried her to the front of the building where EMS personnel met him and the victim was transported to a local hospital.

Because this rescue was performed at extreme personal risk, before proper ventilation had taken place, and without the benefit of a charged line, the Fire

Commissioner/Chief of Department highly commended Fire Fighter Dorian Jenkins of Ladder Company 6 in General Order No. 26 of 2003.

Therefore, the Fire Commissioner, acting on the recommendation of the Board of Merit, hereby orders Fire Fighter Dorian Jenkins of Ladder Company 6 be presented the Walter Scott Medal for Valor.

9. Case of Fire Lieutenant Paul D. Lucas, Engine Company 18

On May 3, 2003, at 0447 hours, Box 3418 was struck for a building fire at 16 Melbourne Street in District 8. Upon arrival, heavy fire was showing from a three-story wood frame building. The fire had started on an enclosed porch, broke through an interior window, extended up the stairwell involving the first, second, third floors, and the front porches of the building. The fire was extending to an additional 2 ½ story wood frame dwelling.

Engine Company 18 immediately ran a line down the left side of the building where occupants were at the second and third floor windows. Members of Engine Company 18 used a fog stream to protect these occupants from the heat of the fire.

Realizing that a ground ladder would not be thrown in time, Fire Lieutenant Paul D. Lucas of Engine Company 18, climbed a fence and entered the rear of the building. He made his way to the third floor under deteriorating conditions, and was making a primary search of several rooms when he heard cries for help. Fire Lieutenant Lucas located a woman and two children in the front room. He was able to hold on to all three, bring them through the heavy smoke condition to the rear stairwell, and down to the safety of the street.

Because this rescue was performed during heavy smoke conditions, before proper ventilation had taken place, or without the benefit of a charged line, this member placed himself at extreme personal risk. The Fire Commissioner/Chief of Department highly commended Fire Lieutenant Paul D. Lucas of Engine Company 18 in General Order No. 24 of 2003.

Therefore, the Fire Commissioner, acting on the recommendation of the Board of Merit, hereby orders Fire Lieutenant Paul D. Lucas of Engine Company 18 be presented the John E. Fitzgerald Medal for Most Meritorious Act.

On June 6, 2004, at 1708 hours, incident #31478, District 1 and Engine Company 5 were dispatched to Chelsea to assist with the search for a missing person off the Chelsea Yacht Club. Upon arrival, Chelsea Fire Department members were in the process of searching for a missing twelve-year-old female in the waters off 100 Captain's Row.

The Boston Fire Department Scuba Team was immediately activated. Fire Fighter/Divemaster Steven Murphy, Marine Unit, Lieutenant Joseph McNulty, Engine Company 17, Fire Fighter Kenneth Marrero, Engine Company 17 and Fire Fighter Joseph Kelley, Rescue Company 1, were the first to arrive. Fire Fighter/Divemaster Murphy consulted with witnesses as to where the girl was last seen. The team members immediately mastered a plan for searching the area. Lieutenant McNulty and Fire Fighter Marrero were to suit up, while Fire Fighter Kelley would be in charge of communications with the team while under water.

Fire Fighter/Divemaster Murphy instructed Lieutenant McNulty to enter the water and begin to search approximately 40 feet off shore in the area where the girl was last seen. Fire Fighter Marrero would be guideline tender and also serve as backup diver. Lieutenant McNulty entered the water under extremely adverse conditions, with strong blowing winds, a strong current, and debris filled water. Against these odds it was within eleven (11) minutes that the young victim was retrieved from the ocean bottom.

2.) The Fire Commissioner/Chief of Department is pleased to commend Fire Lieutenant Michael S. Mullen of Ladder Company 21 who on the night tour of June 27, 2004, at 2247 hours, was able to diffuse and control a dangerous situation in quarters.

The situation began when a young man arrived at the firehouse claiming that he had been assaulted by a group of young men and they were still chasing him. At this time four other men appeared on the scene confronting the first man. As the members who were on the main floor were trying to diffuse the situation, two more men appeared from the side of the firehouse apparently coming to the aid of the first man. Both men were brandishing knives with blades in excess of nine inches long. The incident further escalated when two carloads of men pulled up on the apron to assist the first group of four men. It was at this point Fire Fighter Sifford of Engine Company 56 found himself caught between the firehouse and one of the knife wielding men.

The incident had become very dangerous for both civilians and firefighters alike. It was at this moment that Fire Lieutenant Michael S. Mullen of Ladder Company 21 felt he had no option but to act. Grabbing a broomstick, Lieutenant Mullen was able to knock the knife out of the hand of the man closest to Fire Fighter Sifford kicking the knife away from the incident. He then without hesitation confronted the other knife wielding man also disarming him. With both knives now secured by firefighters, Lieutenant Mullen placed himself between the two groups of men dispersing them. Because of Lieutenant Mullen's quick action, the incident quickly de-escalated to a much less dangerous situation. At this point, Boston Police arrived on scene and assumed control.

Lieutenant Mullen's actions, with complete disregard for his own safety, prevented serious injury to a fellow firefighter, as well as serious injury to the civilians involved in this altercation. His actions reflect the best qualities of the Boston Fire Department. This commendation shall be made part of his personnel file.

I. FIRE PREVENTION WEEK

Fire Prevention Week will be observed in the City of Boston from **October 3 to October 9, 2004, inclusive**.

The theme for this year's Fire Prevention Week is, **"Test Your Smoke Alarm"** The National Fire Prevention Association recognizes the importance of teaching two simple but life-saving lessons. Install smoke alarms and test them regularly and develop and practice home fire drills.

Educational material concerning these lessons will be distributed. All members should familiarize themselves with this information. Company officers shall review with all members the regulations concerning the installation of smoke detectors. This information will assist members in answering questions that the public may have while visiting.

The Fire Prevention Division will distribute **"Test Your Smoke Alarm"** banners. These banners shall be displayed on the front of firehouses from 0800 hours, October 3, 2004, until 0800 hours, October 10, 2004.

Fire stations shall be open to the public between 1200 and 1700 hours for visits of the premises and for the conveyance of information concerning the fire department functions and fire prevention matters. When citizens come to a station during Fire Prevention Week, the member on house patrol shall summon the commanding officer to answer any questions regarding the department, or to have a suitable person assigned this duty.

If a person or group wishes a tour of the firehouse, all hands shall be summoned to the main floor to greet the visitors. Tours shall include explaining how an alarm is received at the firehouse, followed by a demonstration of sounding the house gong, turning on the house lights, and if applicable, having a member slide down the pole.

Members should pay special attention to children during firehouse visits. They should talk to the children about knowing their home address, how to dial 9-1-1, STOP-DROP & ROLL, smoke detectors and having an escape plan to exit their home in an emergency.

If members allow some of the children to try on their helmets or bunker coats, take special precautions with smaller children as the weight of the protective gear may be too much for them. Care should be taken to ensure that no child is injured.

Have a member dress in full bunker gear with an airpack and facepiece on. Explain to the children that this is what firefighters look like when coming into their homes during a fire. Show them the apparatus, turn on the lights and siren, ask for questions and encourage them to take any safety pamphlets that you may have. If additional educational material is needed, it can be obtained by dialing the Public Information Office at 617-343-3415.

District Fire Chiefs are directed to take an active interest in Fire Prevention Programs in the following manner:

By making arrangements with the various plants and industrial enterprises within the district to hold fire drills during the week, by grading these drills as good, fair, or poor, and making a report of same to the Fire Prevention Division, indicating the name of the enterprise, the date of the drill and the grade. Same should be forwarded promptly. Each business should be requested to acknowledge participation in Fire Prevention Week activities via written correspondence. These drills should be conducted by a company officer after arrangements are made. At plants where there are special or company fire brigades, particular attention should be given to assignments and/or response procedures. It is requested that the name of the company officer conducting the drill be furnished. It is anticipated that not less than three drills be conducted in each district.

District Fire Chiefs should make a concerted effort to bring the activities of the department before these organizations and arrange for lectures to be given. The name of any organization so participating should be reported to the Fire Prevention Division, specifically if the organization can be urged to forward on their own stationary a notation of the event, it would be to the greater advantage of the fire department.

Firefighters are to pay special attention to the observance of fire hazards and to the duty of observing and locating fire hazards along the route followed by them in their coming to and going from daily work. All buildings being erected, demolished or significantly remodeled require permits, as do storage and use of flammable gases. Notify your District Fire Chief and/or Fire Prevention Division at extension 3-2191. Dilapidated buildings, rubbish accumulation and the other hazards should be reported in accordance with abatement procedures as outlined in S.O.P. # 25. The public expects uniformed members of the fire department to know something about fire prevention work and to have an interest in this subject since they are public employees engaged in this field. Firefighters, therefore, during Fire Prevention Week, should have this subject uppermost in their minds and they should not pass a fire hazard at any time without making a note of it for reference to the Fire Prevention Division. In short, every uniformed member in the fire department is a fire prevention inspector at all times.

**I. CHANGES TO MANAGEMENT OF INJURY INDEMNIFICATION AND SICK
LEAVE**

Effective 0800 hours on November 1, 2004, the following changes will take place for the Management of Injury Indemnification and Sick Leave:

Pursuant to the collective bargaining agreement, Article XVIII, Sec. 1A, effective immediately, Case Manager Ian Mackenzie is appointed as the Commissioner's designee for the reporting of all work-related injuries. Injured Leave Reports are to be submitted to him in the medical office within 48 hours of the time of injury. In the event that an Injured Leave Report (5-D) is not received by the medical office prior to a member's visit (but within the 48 hours), it is the members' responsibility to complete another form prior to being examined by the Department Medical Examiner.

Any claim for injury indemnification received by the Medical Office more than 48 hours after the time of injury will be denied, and the member initially placed on sick leave pending further investigation. If the investigation determines it is a work related injury any lost sick time will be restored. This reporting process will be followed unless the severity of the injury is such that it makes notification within 48 hours impossible. To that end, in the event that a member is admitted to hospital as a result of a work-related injury, Fire Alarm is to advise the Case Manager and Department Medical Examiner immediately.

Company commanders are to complete an Injured Leave Report (5-D) for every injury sustained on their tour, and forward the report to the District Chief as soon as possible after the injury. It is the injured members' responsibility to make sure this is done. District Chiefs are to fax the front page of Injured Leave Reports (5-D) pertaining to injuries sustained by members assigned to their district, to the medical office prior to the conclusion of said tour. The Medical Office fax number is (617) 343-3042.

Company commanders are to complete a Sick Leave Report (5-S) for every sick call received on said tour of duty. District Chiefs shall ensure they have a (5-S) for every sick call they receive on said tour, and fax them to the medical office on the tour the sick call is received. The Medical Office fax number is (617) 343-3042.

All medical documentation for sick leave will be verified by the medical office only.

Pursuant to the collective bargaining agreement, all personnel are required to complete and sign a medical release, upon initial visit to the Medical Office dealing with the specific injury involved.

Injuries that occur within the firehouse or its grounds shall be investigated by the District Chief immediately. The investigating District Chief shall complete an In-House Injury form (OFS-3) and fax the form to the Personnel Office before the completion of the tour. The Personnel Office fax number is (617-343-4114). The Safety Chief shall also investigate in-house injuries and submit a form 5-A to the Fire Commissioner within 24 hrs.

All applications for indemnification for injuries recognized by MGL Chapter 32, Sections 94, 94A, and 94B (heart, lung, and cancer presumptions) as job related must be made in writing on an Injured Leave Report (5-D). The form is to be submitted to the Medical Office on the first visit to the Department Medical Examiner following diagnosis of an eligible condition.

Members on injured leave should have medical providers fax updated notes to the Medical Office prior to a scheduled appointment with the Department Medical Examiner. The Medical Office fax number is (617) 343-3042.

III. HIGH COMMENDATION

On September 20, 2004, Engine Company 50 responded to the rear of 333 Terminal Street in District 3 for a report of a man in the water. Upon arrival, members observed a man, in obvious distress, about thirty yards from the seawall. Without hesitation, and with no regard for his own personal safety, Fire Lieutenant Donald Doenges swam out to the victim and pulled him toward the shore where he and the other members of Engine 50 then lifted him onto the seawall. The victim was then transported by Boston EMS. It was later discovered that the victim, suffering from diabetes, had become disoriented, and was virtually unable to aid himself once he had fallen into the water.

Because this rescue was performed without knowledge of any hidden obstructions, depth of the water, or presence of a dangerous current, Fire Lieutenant Doenges placed himself at great personal risk. The Fire Commissioner/Chief of Department is pleased to highly commend Fire Lieutenant Donald Doenges of Engine Company 50, and refers his case to the Board of Merit for further consideration.

IV. COMMENDATIONS

1.) The Fire Commissioner/Chief of Department is pleased to commend Fire Alarm Operator Denis Sullivan for his efforts on behalf of the Boston Fire Department on several different occasions. His cooperation and assistance, given willingly and on his own personal time, during the IEEE milestone program in 2004, the Society of Industrial Archeology's conference in Providence, Rhode Island, in 2003, and First Night at the Old State House in 2002, are a few examples of his dedication to duty and his willingness to represent the Boston Fire Department in a most professional and positive manner. This commendation shall be made part of his personnel file.

2.) The Fire Commissioner/Chief of Department is pleased to commend Fire Alarm Operator Lisa A. Gregorio for her efforts in identifying a perpetrator who had been placing calls for needless alarms for an extended period of time.

On October 15, 2004 at 1906 hours a cell phone call was transferred from a 911-call taker to the Fire Alarm Office reporting a building fire in District 9. Upon arrival, companies reported “nothing showing” and the District Chief ordered the Fire Alarm Office to check the still.

At this time Fire Alarm Operator Gregorio, remembering numerous calls from this address, reported that this had been an ongoing problem. Using the CAD system, Operator Gregorio determined that more than forty (40) such incidents had occurred since September 1, 2004. She contacted Verizon Wireless Security and was able to confirm the location. The District Chief was informed of the findings and ordered the Fire Investigation Unit and Boston Police to respond. After investigation, it was determined that a teenage boy living at the address was responsible for the rash of false calls. He was placed under arrest.

The success of this investigation was due to the professionalism and dedication of Fire Alarm Operator Gregorio. This commendation shall be made part of her personnel file.

3.) The Fire Commissioner/Chief of Department is pleased to commend Fire Fighter Eddy E. Holmes of Ladder Company 21, who while off duty on October 26, 2004, at 1809 hours, responded to Box 6173 for a building fire at 265 Meridian Street in District 1. He assisted the members of Ladder Company 21 with several different assignments thus allowing them to accomplish these objectives in a more timely fashion. His actions reflect the highest standards of the Boston Fire Department. This commendation shall be made part of his personnel file.

I. SUBJECT BUILDING PRE-FIRE PLANS

As a result of a FEMA Fire Act Grant, the Department has undertaken a landmark project, known as the "Rapid Information and Early Warning System" (RIEWS). This project will place touch-screen laptop computers (MCT) in all engine company's apparatus and Chief's vehicles. The project has been underway for the past month and is about 20% complete. We anticipate the system to be operational by early April, 2005. The primary purpose of these computers is to give responding members access to critical information that pertains to the incident they're responding to. The critical information includes dispatch information, maps with hydrant locations, hazardous building information, and building preplans. This information, available while enroute at the touch of the computer screen will greatly benefit firefighter safety and also that of the citizens we protect.

Building preplans are a significant component of the RIEWS MCT project. In an effort to get this critical information into the hands of responding companies and the Incident Commander, the Information Technology (IT) Division is working with a software program to digitize building preplans, hazard information, and site plans of certain "target hazards" into a database that would be available while responding and at the scene of an incident. This will mean that preplans that are currently carried in the usual three-ring binders must be converted into electronic format and stored within the laptop computers. And, in order to maximize the benefit of the computer's capabilities, additional building preplans must be developed by all fire companies with the assistance of their Chief Officers and the IT Division. A feature of this system is that all preplans will be available on the laptops of all engine companies in the City. The advantages to covering companies are obvious.

Therefore, beginning immediately, all fire companies shall begin to develop building preplans for locations in their respective sub-districts. Locations that are recommended include: apartment buildings and multiple building residential complexes, nursing homes, elderly housing complexes, high rise residences, commercial occupancies with obvious hazards to the public and firefighters, target hazards that pose a significant threat to the general population. The order that they are done will depend on the assessed risk to life (both civilian and firefighters) & and the probability of an incident, both fire and non-fire. Deputy and District Chiefs will provide guidance to company officers who are unsure of which locations to preplan. The Captain will organize the list to be done and apportion the workload equally among the four work groups. Lieutenants and Senior Firefighters will forward building preplans through the company Captain for approval as to accuracy and completeness of the information provided. The Captain will forward through the District Chief on their work group who will review and approve as completed. District Chiefs will work with the companies of which the Captain is assigned to their work group. Deputy Chiefs will similarly oversee their District Chiefs. The Deputies will review and forward all approved preplans to the IT Division for entry into the computerized system. The MCT Building Preplan Program is ongoing and will continue permanently. Chief Officers will supervise the Program and will see that all companies under their command submit preplans every month.

Accompanying this order are standardized forms that are to be used for completing building preplans. The two-pages entitled, *First Look Pro Preplan Inspection Form*, will be filled out completely.

Depending on what type of occupancy is being preplanned, other important information will be listed in a narrative format in the sections marked "*Notes*". The Captain must review this information to validate that the proper information, consistent with the occupancy, is included. Similarly, Deputy Chiefs and District Chiefs, when reviewing their company's preplans, will consider the content of this additional information. The back of the second page, marked "*Site Diagram*", will be used to draw a rough diagram of the building footprint. This outline of the building should be shown on the site plan in relationship to the property and surrounding streets. Measurements, streets, hydrants, Fire Department Connections (FDC), fences, entrance points, etc should be included as appropriate. A "NORTH" compass coordinate, including an arrow, should also be shown. The page includes gridlines to assist you in drawing straight lines. The more detailed your diagram is, the more useful it will be to all who look at it on the laptop. If photographs of the location would add necessary information to the preplan, an IT Division staff member will visit the site and take digital pictures, at the officer's direction. These photos can be added to the preplan and viewed on the laptop enroute to an incident.

My sincere thanks to each and every one of you, uniformed and civilian, for all that you do in keeping Boston one of the safest cities in the nation.

II. HIGH COMMENDATION

On September 23, 2004, at 1917 hours, Engine Company 33 and Ladder Company 15 were dispatched to the Massachusetts Avenue Bridge for a report of a woman in the river.

Upon arrival, it was confirmed that a woman was in the water up to her neck clutching a piling at the base of the bridge. While a member of Ladder Company 15 prepared to don a survival suit the woman began shouting that she could not hold on any longer. At that moment, Lieutenant Robert Moriarty was lowered by rope approximately thirty-five feet to the river where he was able to secure the woman in distress and keep her head above water until the arrival of the State Police boat.

Fire Lieutenant Moriarty acted without regard to his own personal safety in effecting the rescue of this woman. He placed himself at great personal risk by entering the water and had he not done so, the victim would have slipped below the surface of the moving river and the opportunity to save her life would have been lost. He suffered abrasions to his arm and hand, and also ingested river water during this rescue. He was transported to the Boston Medical Center where he was treated and released.

Because this rescue was performed at great personal risk, without the benefit of a survival suit, The Fire Commissioner/Chief of Department is pleased to highly commend Fire Lieutenant Robert Moriarty of Engine Company 33, and refers his case to the Board of Merit for further consideration.

III. COMMENDATION

The Fire Commissioner/Chief of Department is pleased to commend Engine Company 33 and Ladder Company 15 for their diligence and teamwork on September 23, 2004, 1917 hours, at incident #04-51446. Both companies responded to the Massachusetts Avenue Bridge for a report of a woman in the water. Upon arrival, it was confirmed that a woman was clutching a piling at the base of the bridge in neck deep water.

When it became obvious that the woman could hold on no longer the members of Engine Company 33 and Ladder Company 15 used a rescue rope to lower Fire Lieutenant Robert Moriarty of Ladder Company 15 into the water. He then rendered assistance to the woman until the arrival of the State Police boat. Their actions reflect the highest standards of the Boston Fire Department. This commendation shall be made part of their personnel file.
