## Hotel Gone at Forest Hills.

A fire that swept through the north section of the Forest Hills hotel, at the junction of Hyde Park av and Walkhill st. Jeager, and assistant manager Stephen Walsh, who forced their way through the smoke-filled rooms and rescued Mrs William F. 

Heavy Sunday Business.
The hotel is a three-story wooden structure, 51 to 61 Hyde Park av, having a frontage of 158 feet on Hyde Park av and a long frontage on Walkhill st. It is triangular in shape, and contains 35 rooms. The north portion, numbered 51, 53, 55 Hyde Park av, and running back to Walkhill st, was the part burned.
That section of the hotel contained a large winercom in the basement, containing \$6000 worth of wines and liquors and a rathskeller. On the first floor were the office and two large rooms; saloon on the second, nine private dining rooms, with parlor and kitchen at the rear; on the third floor, 12 chambers and bath rooms.
Sunday is one of the busiest days at the hotel, which caters to a very large out-of-town patronage. Yesterday the livsiness was unusually heavy and at about 400 guests.
These rooms were on the street floor, and directly back of them is a large plaza that runs to above the second story. There is an exit from the lotel at the end of the plazza on the Walkhillst side.

### Saved in Nick of Time.

Saved in Nick of Time. Annose at once the names were fore-ing their way through the windows into the building, driven by a strong wes-wind, and the guests tumbled over each other in their haste to escape. Mr Selberlich quickly rang the hotel fire alarm, then telephoned station 11 that the hotel was on fire; shut the safe, and with manager Jeager and assistant manager Walsh hurrled through the hotel and rescued the worgen mentioned. Mrs William O'Connor was carried out of the building by Stephen Walsh and her little son William by Mr Selberlich. During this time the fire department of the hotel, composed of Otto Luskars, William Conucly, John Eberhardt, Wil-liam Reinhardt, Peter White and John Reiliy, got out a line of hose and en-deavered to check the flames. Knowing that Mrs Leach, Mrs Ben-son and Mrs Brady were at work in the hitchen in the second story, directly above the heart of the fire, Mr Selber-lich and Stephen Walsh forced they way through the smothering smoke that now filled the building, up the narrow stalrway to the second story, and brought out the three women in the nick of time. A few minutes later the room in which they had been was a mass of flames. Scocad Alarm Ordered.

### Second Alarm Ordered.

Second Alarm Ordered. Patrolman George Keyes of division 13 was on Washington st not far from the rear of the hotel when he saw a sheet of flame shoot almost across Walkhill st. He jumped upon a pass-ing car and ordered the motorman to make all speed to box 531, at the corner of Washington and Morton sts. Someone on Hyde Park av called to a passing driver of a hack that the hotel was on fire and to rush to box 592 at the corner of Weldhill and Wachusett sts. He whipped up his horses and leached box 563 before patroiman Keyes sounded box 563. The fine made such rapid headway, fed by the hard wood of the hotel and fanned by a strong westerly breeze, that when Dist Chief Michael J. Mullgan got sight of the fire he ordered a sec-nd alarm before he left his wagon. Engine 28 and ladder 10 of Jamaica Plain was the first apparatus to arrive. Engine 46 and ladder 16, Roslindale, foi-lowed closely. #### Fight Watched by 5000.

Fight Watched by 5000. The second alarm brought addition-al apparatus from Roxbury, West Roxbury and Mattapan. The fire, which was most spectacu-lar, was witnessed by more than 5000 people, who crowded Hyde Park av, Walkhill at and Washington st. A crowd of 2000 men, women and chil-dren watched from the raised tracks of the N - Y, -N + & + H until driven

from their dangerous position by the police. Ladders were thrown up on the Hyde Park-av frort of the hotel, on the hotel Meyer and against the rear walls of the Forest Hills hotel. From there the firemen poured a deluge of water directly into the heart of the tire. The heat from the fire was al-most unbearable. Senior hoseman Wesley Newdick of engine 42. Egle-ston Square, was overcome and was compelled to relinquish his task. His place was supplied by hoseman Grif-fin of chemical 5. Egleston Square. Ladderman Stephen A. Moran of ladder 16, Roslindale, while trang down a line of hose on a ladder on the Walkhill-st side of the hotel, fell and injured his right leg. Hoseman Fall of engine 28 was also slightly over-come. After two hours the firemen won.

Carelessness Probably the Cause.

Carelessness Probably the Cause. EX-Senator Selberlich, proprietor of the hotel, was loud in his praise of the work of the firemen and told Dist Chief Mulligan that the men of the depart-ment would hear from him later. He also assured all the employees of his hotel, who had lost their belongings in the fire, that he would reimburse them. Mr Selberlich carried an insurance of \$10,000 on the contents of the hotel. Mr Gougeon, owner of the building, is also well insured, and it is understood that Mr Miller's loss is also covered by in-surance. The south section of the hotel, with entrance at the junction of Hvde Park av and Walkhill st, which contains the bar on the first floor and 20 chambers ou-the floors above, was but little dam-aged as Mr Selberlich closed the iron fire doors separating the two sections of the hotel. It is expected that the hotel will be rebuilt at once. A lighted match carelessly dropped through a crack in the plazza is be-lieved to have started the fire.
