## REPORT OF INSPECTOR OF WIRES.

# To the Board of Fire Commissioners:

Gentlemen: I hereby submit a report of the work done by this bureau from June 1, 1891, to Feb. 1, 1892, covering the inspection of buildings in which electric currents of high and low potential are used for lighting and power service, under ground service of various companies, the plant of the West End Street Railway, the Fire-Alarm Telegraph, and other features relating to electric service, as far as the work has been carried on since this department has been in active operation.

An order has been passed by the Board of Aldermendirecting this department to examine and report the number of pole locations which have been accepted by various companies doing business in the city. The requirements of this order are now being carried out, and about 5,500 of the 7,000 locations granted have been examined.

Plans of streets, showing the locations of poles which have been granted by the Board of Aldermen, are now being pre-

pared in the office of the Inspector.

The underground service of the New England Telephone and Telegraph Company is obtained by the use of conduits of which four different kinds are used, viz.: Wrought-iron pipe in concrete, cement-lined iron pipe in concrete, creosoted wooden boxes and vitrified clay pipe.

The work was commenced in 1882, and conduits ranging from two to fifty ducts each are now laid in Boston proper,

South End, Back Bay, and Charlestown, as follows:

The underground cable system of this company consists principally of lead covered cables, varying from twenty to two hundred copper wires in each, and the total amount in Boston, Jan. 1, 1892, is:

The Edison Electric Illuminating Company have about forty miles of conduits, and there are two miles in use by the Western Union Telegraph Company.

The West End Street Railway Company have 58,226 miles of electric lines in Boston, using two hundred and forty-two long and forty-seven short cars, producing 5,920 electrical horse-power at its central power-station, and 1,120 at the station in Allston.

I have recently procured a test-board of comprehensive design and elaborate finish, and have placed it in service at headquarters, for the purpose of testing the carrying capacity of wires, switches, cut-outs, etc., and for ascertaining the amount of current necessary to fuse automatic cut-outs, and safety devices of all kinds. Also for testing the insulation of wires, and for such electrical experiments and demonstrations as may properly come before this department for examination or illustration.

I desire in this connection to call the attention of your honorable Board to the fact that the ordinance under which the Department for the Inspection of Wires was organized does not give to the Inspector sufficient authority to enable him to properly carry out the purpose for which it was formed, and while the various companies have generally cheerfully acquiesced in the suggestions which have from time to time been made to them, it is evident that far greater results might be obtained if the power of the Inspector should be extended and more clearly defined. I would therefore recommend that some action be taken to this end.

The new construction and repair work done for the maintenance of the Fire Alarm system within the year ending February 1, 1892, is as follows:

Alarm circuits 1, 3, 9, 11, 18, 22, 23, and 24, and telephone circuits 4, 9, 10, and 13, have been rebuilt from head-quarters to the corner of Congress and High streets; circuits 18 and 22, and telephone circuit 15 partially renewed to Western avenue, and alarm circuits 6, 12, 15, and 16; boxgong circuits 30 and 32 reconstructed from Sudbury street to Warren bridge.

Fixtures have been rebuilt and arms placed on same for renewal of alarm circuits 2, 7, 8, 13, and 19, box-gong circuit 31, and telephone circuits 7, 8, and 25, on the Tremont-

street route from headquarters to Camden street.

A new telephone circuit has been constructed connecting the house of Commissioner Innis with the system, and circuits 17 and 27 have been made metallic for the purpose of destroying induction from high-tension currents, which at times seriously interferes with the successful operation of the service.

No. 25 has been partially reconstructed, and others will be changed to a metallic basis as soon as the routine work of reconstruction and repairs on the general system will

permit.

Fixtures have been rebuilt, enlarged, and repaired; old poles taken down, new ones set in their places; others set for extension of the service, and new wire run in various localities throughout the city, where the conditions have required such work to be done, and five hundred four, six, and eight-pinned arms have been placed on a line of new poles set by the Postal Telegraph Cable Company from Congress-street bridge to Dedham line, to be used in future construction.

Sixty-eight new poles have been set and one hundred and

one old ones taken down during the year.

Twenty-four signal-boxes have been added to the system, and new apparatus boards placed in the houses of Engines 24, 28, 32, 36, and 40, Truck 17, Chemical Engines 7 and 8, and the new houses at Egleston square and Allston; Engine 40 and Truck 17 being also supplied with new fire-alarm apparatus.

A sub-marine cable has been laid at the draw of Congress-street bridge, and a twenty-five conductor over-head cable run from headquarters to Simmons building on Water

street.

The work of new construction will be carried on as fast as the routine work of the service will permit, and for this purpose I propose to make use of copper wire of larger size than has been used heretofore, in order to ensure greater tensile strength and better conductivity.

I also propose to construct one circuit with covered iron wire, as an experiment, with the view of adopting it in

future work if it gives satisfactory results.

A constant watch is kept at the headquarters, City Hall, night and day, by the operators. Each set of operators have assigned to them certain hours of duty, during which time they are responsible for the correct working of the apparatus in giving alarms, and all testing of the circuits and other details pertaining to the service. An automatic arrangement is connected with the receiving apparatus, by which assistance may be called from the sleeping apartments, if at any time the operators should be suddenly incapacitated by illness from performing their duties. No operator is permitted to sleep during his watch, unless expressly relieved by some one else, and by consent of the Superintendent.

Each operator is accountable to the Superintendent for any mistakes that may occur at the office during his hours

of duty.

An accurate account is kept of the time of giving each alarm, and of the station from which it originates, and all other necessary information.
