- 1. At 10:15 p. m., January 23, 1959, the department responded to a fire in the dwelling house at 15 Bragdon St., Roxbury. Upon arrival of the department, heavy smoke and fire were coming from the second floor front windows of a two-family wooden frame house located on the corner of Bragdon and Notre Dame Streets.
- 2. Fire Lieutenant Biaggi Germano of Engine Co. 42 ordered a line to be operated from the street on the overlapping fire, and a second line was started via the front stairs to the second floor. At the top of the stairs, a door was found jammed half open leading to a narrow hall. On the right leading from the hall there was a room with a door opening on to a rear piazza. A man in night clothing was standing in the piazza door shouting that a child was still in the apartment.
- 3. Fire Fighter Wilbur Luacaw of Engine Co. 42 groped by the jammed door into a narrow hall. To the right was a large sitting room involved in fire. Straight ahead there was a small bedroom and inside the bedroom door Fire Fighter Luacaw found a seven year old child unconscious on the floor. He picked her up and carried her downstairs to the street. She was removed to the hospital suffering from burns over 90% of her body and died the following day.

- 4. Ventilation was not yet effective at this early stage of operations, and Fire Fighter Luacaw did not have time to don a mask. He was partially overcome from the effects of smoke and heat, and was given first aid at the scene.
- 5. Because of the danger to which he exposed himself (the apartment was charged with fire, heat and smoke) without regard for his own safety, the Fire Commissioner is pleased to highly commend Fire Fighter Luacaw, and his case is referred to the Board of Merit for further consideration.

VI. J.F. FITZGERALD EXPRESSWAY TUNNEL

An underground section of the John F. Fitzgerald Expressway under Dewey Square has recently been opened to traffic. A survey has been made to establish an operational procedure for the Department to follow in handling fires or other emergencies at this location. A description of the fire protection facilities available and the procedure to follow for apparatus responding to this location is as follows:

Description

Dry Pipe Line and Discharge Outlets

A six inch (6") dry pipe fire line has been incorporated into this tunnel, and it runs from a point opposite the corner of Oliver Street on the Southbound side, under the dividing wall, to a point at the corner of South Street and Waverly Place, This pipe has a length of approximately 1475 feet. (Eventually it will extend the full length of the completed tunnel.)

The dry pipe fire line is connected into the domestic low service with the connections controlled by post indicator valves; one on Purchase Street opposite Oliver Street, and the other at the corner of South Street and Waverly Place just outside the traffic control building. In addition, there is a three-way inlet, equipped with clapper valves, located at the portal of the tunnel at a point just south of Oliver Street. This inlet can be used to supplement the water supply to the pipe line whenever pressures or volumes become inadequate due to the number of streams being operated.

As the pipe line proceeds through the tunnel, there are five, six-inch risers connected to it. The first riser is located about 65 feet inside the tunnel going South, and the remaining risers are located at intervals of approximately 250 feet apart. Connected to each riser are four, $2\frac{1}{2}$ gated outlets, two outlets located in the Southbound lane and two in the Northbound lane on the dividing wall of the tunnel. There is a metal connecting door in the dividing wall at each riser, thus making the outlets on both sides of the wall accessible. The total number of 22" outlets available in this part of the tunnel is twenty.

VI. J.F. FITZGERALD EXPRESSWAY TUNNEL - Cont'd.

The pipe line is equipped with a low point drain located in the Northbound lane about 375 feet from the Oliver Street end of the tunnel. This is a manually operated drain valve similar to a Morse gate. It is located in a small manhole in the catwalk with the manhole openingprotected by a diamond plate cover. There is a sign "DRAIN VALVE" at this point. The outlet from this drain connects into an adjacent catchbasin. For the purpose of maintaining continual drainage, and to provide venting facilities for the removal of air pressure which could develop while the system is being filled, the low point drain shall be left open two (2) turns. After the system has been used and is in the process of being drained an air vent should be provided by leaving one of the 2½" outlets open until drainage is complete.

Extinguishers

There are eight 15-pound Carbon Dioxide extinguishers provided for emergency use in the tunnel. They are located in metal cabinets in the dividing wall of the tunnel. There are four such metal cabinets and they are adjacent to the metal connecting doors in the division wall of the tunnel. These extinguisher cabinets extend through and are accessible from either side of the tunnel. Each cabinet contains two of these 15-pound CO2 extinguishers and has the marking "FIRE EXTINGUISHER".

Fire Alarm Boxes

The tunnel is equipped with fire alarm boxes and at this time the following are in service:

Box 12-141 John F. Fitzgerald Expressway, Southbound, Station No. 1, Tunnel near Congress St.

Box 13-141 John F. Fitzgerald Expressway, Southbound, Station No. 3, Tunnel, Summer Street Under

Box 14-141 John F. Fitzgerald Expressway, Southbound, Station No. 5, Tunnel, Lincoln Street Under

Box 16-143 John F. Fitzgerald Expressway, Northbound, Station No. 2, Tunnel, near Congress Street

These are all standard fire alarm boxes equipped with telegraphers! key and telephone jack.

Emergency Telephones

Emergency telephones are located on the walls of the turnel one beside each fire alarm box. These telephones are connected directly to the traffic control office at South Street and Waverly Place. They may be used by the public to report emergencies and by the Fire Department to contact the traffic control center durin fires or emergencies to stop traffic, starting or stopping ventilating fans, or similar reasons. They should not be used to relay messages to the Fire Alarm Office except under very unusual circumstances.

VI. J.F. FITZGERALD EXPRESSWAY TUNNEL - Cont'd.

Ventilating System

The tunnel is equipped with three sets of exhause fans to control the carbon monoxide content of air in the tunnel area. These fans are manually controlled from the traffic control office at South Street and Waverly Place. By means of graph machines, the carbon monoxide content of the tunnel is constantly recorded. The fans can also be used for the removal of smoke or fumes from the tunnel in event of fire.

In order to have these fans storted or stopped, the tunnel telephone should be used. There will be two men on duty in the traffic control office at all times to attend to this matter. Near the Northbound entrance there are three large blank wall structures and these form the outlets for the exhaust system.

Department Operating Procedure

In the event of a fire in the tunnel, Engine Co. 25 and Ladder Co. 8 will respond via the Southbound entrance, off Purchase Street near Oliver Street. It shall be the duty of the pump operator of Engine Co. 25 to immediately open the POST INDI-CATOR VALVE, located at this entrance. After attending to this, he will position his pump adjacent to the three-way inlet which is located just outside the tunnel portal as previously described. This places him in a position to receive and connect any lines that may be laid, if conditions require, to supplement the tunnel fire line. The wagon of Engine Co. 25 shall proceed to the tunnel and lay the necessary line or lines from available $2\frac{1}{2}$ gated outlets.

Engine Co. 7 and Ladder Co. 17 will respond via the Northbound entrance at South Street near Waverly Place. It shall be the duty of the pump operator of Engine Co. 7 to immediately open the POST INDICATOR VALVE at this location. He shall then assume a tentative position at the post hydrant at that location. The wagon of Engine Co. 7 shall proceed to the tunnel and run the necessary line or lines from available $2\frac{1}{2}$ gated outlets.

Ladder Cos! 8 and 17, in responding to boxes in the tunnel, shall so locate that they do not obstruct the roadway in either direction.

Engine Co. 39, the third engine company assigned, shall respond and take a tentative position at the post hydrant opposite 560 Atlantic Avenue with both wagon and pump. They shall be available at that location to run lines with proper pressure, if necessary, to the three-way inlet previously described, or to take such other action as the officer in charge at the fire may direct.

If, for any reason, other companies are designated to carry out the assignments of the preceding companies, they shall follow the procedure as established above.

VI. J.F. FITZGERALD EXPRESSWAY TUNNEL - Cont'd.

The POST INDICATOR VALVE is opened by using an adjustable hydrant wrench and rotating the valve in a counter-clockwise direction. (This is the REVERSE of our standard hydrants.) There is a target window on the POST INDICATOR VALVE to indicate whether the valve is "OPEN" or "SHUT" and an arrow to indicate the direction of rotation to open the valve.

It shall be the responsibility of the District Fire Chief responding to alarms from this location to ascertain that the POST INDICATOR VALVES have been opened and that after use they have been shut down and the system has been properly drained to prevent freezing. In order to restore the drain valve to its normal operating position, it shall be closed down and then backed off two turns.

Tests have shown that radio contact can be maintained with Fire Alarm, under normal conditions, in that section of the tunnel at present open to traffic. However, in the event of radio failure, the fire alarm box telephone or telegraph key can be used to maintain contact with the Fire Alarm Office.

VI. HIGH COMMENDATIONS

1. At 11:02 a.m., February 14, 1959, the Department was called to the scene of a drowning in Muddy River at Charlesgate East and Charlesgate West.

Upon arrival of the apparatus, members of Ladder Co. 15 crawled over the ice with ladder and life line and rescued an M.D.C. police officer who was in the water hanging on to the edge of the ice after attempting to rescue two boys who were in the river.

Members of Engine Co. 33 launched their boat, after breaking through the ice, and rowed toward the spot where the two boys were reported to be submerged. Fire Fighters Frank Gambardello and John Nicholas of Engine Co. 33, and Fire Fighter James L. Fitzgibbons of Ladder Co. 15, broke through the ice, dove into the water and searched the bottom of the river in an attempt to locate the missing boys. After diving and swimming in the frigid water, Fire Fighter Gambardello located the body of one of the boys and with the assistance of Fire Fighters Nicholas and Fitzgibbons the body was removed to shore. This rescue work was accomplished in frigid water, and the air temperature was approximately 35° to 40°F. at the time.

Because of the great risk to which the foregoing members exposed themselves, without regard for their own safety in performing this rescue work, the Fire Commissioner is pleased to commend them highly and their cases are referred to the Board of Merit for further consideration.

2. At 10:58 p.m., March 28, 1959, the Department responded to an alarm from Box 1258 (3 alarms) at 142-144 Blackstone Street.

Members of Ladder Co. 12 were operating on the second floor of the building when an explosion occurred involving the entire area

with fire and intense heat. Members of the company had to make a hasty retreat through windows at the front of the building, some jumping to the street and others sliding down ladders.

Fire Lieutenant Warren A. Hardy, Jr., of Ladder Co. 12, on reaching a ladder outside one of the windows, took a position there and directed members of his company to safety. A fire fighter appeared at the window inside the building in a dazed condition and Lieutenant Hardy reached over and grabbed him, dragging him over the window ledge while flame beat at both of the men. Lieutenant Hardy's ears were burned during this rescue work.

Because of the fact that Lieutenant Hardy remained at the top of the ladder under very hazardous conditions, without regard for his own safety, and succeeded in pulling Fire Fighter William J. Carey of Ladder Co. 12 out of the building, the Fire Commissioner is pleased to commend him highly and his case is referred to the Board of Merit for further consideration.

3. At 10:58 p.m., March 28, 1959, the Department responded to an slarm from Box 1258 (3 alarms) for a fire at 142-144 Blackstone Street.

During the progress of the fire, an explosion occurred on the second floor resulting in the entire floor becoming involved by fire and intense heat. Members of Engine Co. 8 and Ladder Co. 12, who were operating within this floor, had to make a hasty retreat through three windows in the front, some jumping to the street and others sliding down ladders. Four of these men were removed to the Massachusetts General Hospital. It was reported that Fire Fighter William J. Carey of Ladder Co. 12 was missing at that time.

Fire Fighter John L. Campbell of Ladder Co. 12 ran up a ladder to a window on the second floor where Fire Fighter Carey was last seen. Upon reaching the window, from which considerable fire was issuing, Fire Fighter Campbell leaned in so far that only his feet were showing on the sill. While his feet were being held by Fire Fighter Louis S. Toscano of Ladder Co. 12, Fire Fighter Campbell groped around the floor near the window area in a search for Fire Fighter Carey. It was necessary to direct a deck gun stream into the window to afford some measure of protecting for Fire Fighter Campbell. However, due to the terrific volume of fire, he had to climb down the ladder to the street.

A few minutes later, Fire Fighter Campbell again ascended the ladder and made another search for Fire Fighter Carey under very hazardous conditions. It was then learned that Fire Fighter Carey had already been removed from the building. Fire Fighter Campbell, although equipped with an All-Service Mask, received burns to both ears and the back of his neck.

Because of the great hazard to which he was exposed during his unsuccessful search, the Fire Commissioner is pleased to highly commend Fire Fighter John L. Campbell and his case is referred to the Board of Merit for further consideration.

4. At 8:19 a.m., April 9, 1959, Box 1554, the Department responded for a fire at 4 Claremont Street.

Upon arrival of the Department, Fire Lieutenant Francis J. Cummings of Ladder Co. 13 was informed by a woman occupant of the second floor that her three year old son was trapped by fire and smoke on the second floor.

Fire Lieutenant Cummings proceeded to the second floor by way of a front fire escape, forced his entrance to a bedroom, located the boy who was suffering from burns and smoke inhalation, and removed him to the street. The rescue was performed under very hazardous conditions before ventilation had been effected or hose lines were in operation. There was a heavy concentration of heat and black smoke due to burning fuel oil in the apartment at that time.

Because Lieutenant Cummingsperformed the rescue work at great personal risk and without regard for his own safety, the Fire Commissioner is pleased to commend him highly and his case is referred to the Board of Merit for further consideration.

I. BOARD OF MERIT

The Board of Merit of the Boston Fire Department, consisting of the Chief of Department, Assistant Fire Chiefs, and Deputy Fire Chiefs, has considered all meritorious acts referred to it for the year, 1958. After careful consideration and study, the Board submitted the following recommendations which are hereby approved by the Fire Commissioner:

1. Case of Fire Fighter William B. Linnane, Ladder Co. 14

At 2:07 p. m., January 11, 1958, the department responded to a still alarm which developed into a three alarm fire in a three-story apartment house located at 11 Gorham Street, Brighton.

Upon arrival of the department, the rear of the building was involved in fire and a heavy concentration of smoke was issuing from the front of the second and third floors. There were occupants in the building at the time.

The members of Ladder Co. 14 raised a 40' ladder to a third floor window. This was accomplished with considerable difficulty due to the icy pavement. Fire Fighter Linnane ascended the ladder and entered a third floor window. After a search of the apartment, he found a woman lying on the floor in a semiconscious condition. He dragged her to a window, called for a ladder, and when the ladder was raised to the window, he passed the woman out to a fire fighter on the ladder. After descending the ladder himself, Fire Fighter Linnane collapsed and was removed to St. Elizabeth's Hospital.

Because Fire Fighter Linnane accomplished the rescue at great risk and without regard for his own safety, under very trying conditions, the Fire Commissioner commended him highly in General Orders No. 5 of 1958. The Board recommends that his name be placed on the "Roll of Merit."

2. Case of Fire Fighter William E. Pero, Ladder Company 3

At 6:22 a. m., January 19, 1958, the department responded on a still alarm for a fire in a tenement building at 413 Shawmut Avenue, Boston. Box 1671 (3 alarms) was struck for this fire.

During operations at this fire, Fire Fighter William E. Pero of Ladder Co. 3 was ordered to ventilate the roof of the building via an aerial ladder. As he passed a front dormer window he heard moans emanating from within. He climbed up the sloped roof and removed the skylight over the stairway and also cleaned out windows in a cupola in the roof. Being unable to enter the dormer window because of fire conditions, he once again climbed to the roof across the ledge and down to a rear dormer. From this point he got to a fire escape, cleaned out the window and entered a large size attic bedroom. He searched the bedroom and then opened a door leading to a hall opposite the stairs. However, he was driven back by the volume of heat, smoke and gases. He made a second attempt, entered the stair hall and groped his way to the front of the building where he came upon an unconscious man in a bedroom. He attempted to drag the person to the front of the building, but became exhausted and left his victim momentarily to get his wind back. Upon returning to locate the unconscious man, he encountered

a second person who was in a semiconscious condition. He brought the latter to a window, lifted him to the sill and onto an aerial ladder outside. As he started to carry the victim down the ladder, he called to a fire fighter, on another aerial swinging into the building, that there was another man in the room. Because of the severe bodily punishment to which Fire Fighter Pero was subjected, he was taken to the Boston City Hospital.

Because Fire Fighter Pero performed the rescue work under very hazardous conditions caused by heat, smoke and gases, and without any thought of his own safety, the Fire Commissioner commended him highly in General Orders No. 8 of 1958.

The Board recommends that he be awarded the "John E. Fitzgerald Medal."

III. Cases of Fire Fighter Leon G. Crispo, Ladder Co. 12
Fire Fighter William H. Halpin, Ladder Co. 13
Fire Fighter Robert L. LaRose, Ladder Co. 13

During the fire at 413 Shawmut Avenue, Fire Fighter Leon G. Crispo of Ladder Co. 12 was standing on the tip of the aerial ladder and about to further ventilate the roof when he heard cries for assistance coming from the direction of the front attic windows. He directed the placing of the aerial of Ladder 12 to the ledge outside said attic window where he was told by Fire Fighter William E. Pero that a man was in the attic. Upon hearing the moaning, Fire Fighter Crispo smashed in a double window and entered the room.

About this time Fire Fighters William H. Halpin and Robert L. LaRose of Ladder Co. 13 ascended an aerial ladder to the fire escape in the rear and entered the building through a rear window. They crawled and groped their way through the attic to the front of the building, searching as they proceeded. As they entered a front bedroom, they met Fire Fighter Crispo who had jumped through a front attic window. The three fire fighters carried the unconscious man to the front window where he was taken down Ladder 12's aerial to the street.

The rescue was performed under very difficult conditions as the attic was heavily charged with heat, smoke and gases and no water lines were being operated in the area at the time.

Because of the fact that these men exposed themselves to great risk, without regard for their own safety, the Fire Commissioner commended them highly in General Orders No. 8 of 1958.

The Board recommends that their names be placed on the Roll of Merit.

IV. Case of Fire Fighter William A. Dower, Rescue Company.

At 12:28 p.m., January 31, 1958, the Department responded to Box 1347 for a fire in the tenement house at 103 Brighton Street, West End.

Upon arrival, Ladder Co. 24 was informed by District Fire Chief Aylward that two children were trapped in the third floor apartment. The ladder was raised to a third floor bedroom window and Fire Fighter William A. Dower of the Rescue Company ascended the ladder. He forced the window open and had to push aside a bureau and television set which were blocking his entrance. The fire had extended from the parlor to the bedroom, which was involved with intense heat, smoke and flame. Despite the dangerous condition of the room, Fire Fighter Dower crawled along the floor and found a child at the extreme end of the lower tier bunk bed (the upper bunk was in flame at the time), approximately six feet away from the window from which he had entered. Fire Fighter Dower crawled back to the window and passed the child to Fire Lieutenant Stephen Riley who was standing on the ladder at the window. At this time, Fire Fighter Dower was in a weakened condition due to the bodily punishment he had already received, but he again entered the room and found a second child in the same bunk bed. He carried the child to the window and passed it to Fire Lieutenant Riley and descended the ladder himself. Both children were badly burned and were removed to the Massachusetts General Hospital.

Because of the extreme risk to which Fire Fighter Dower exposed himself, without any thought for his own safety, as he was not equipped with any type of mask, the Fire Commissioner commended him highly in General Orders No. 8 of 1958.

The Board recommends that he be awarded the "Patrick J. Kennedy Medal."

V. Case of Fire Fighter Warren J. Cudmore, Ladder Co. 18

At 6:43 p.m., March 14, 1958, the Department responded to an alarm from Box 7143 for a fire in a warehouse at 12-31 Fergo Street, South Boston.

Fire Fighter Warren J. Cudmore was assigned to open the main freight house door which consisted of two sliding doors which were not locked. Upon entering this double door, he saw a fire which had burned through a false ceiling in a locker room which was located immediately adjacent and to his right. As he passed the locker room door to investigate any extension of fire, he heard a moan coming from the room involved in fire. He forced the door of the locker room and found fire involving materials, partition walls, and ceiling. The overhead fire was approximately at shoulder height so Fire Fighter Cudmore dropped to the floor and crawled approximately six feet but was unable to locate the person until he heard a moan to his right. He then found a man lying on a bench, lowered him to the floor and pulled him bodily from the room, by the feet, to a clear area.

Fire Fighter Cudmore was not equipped with a gas mask, and no water line was in operation at the time.

Because Fire Fighter Cudmore performed the rescue work under severe fire conditions without regard for his own safety, the Fire Commissioner commended him higly in General Orders No. 14 of 1958.

The Board recommends that his name be placed on the Roll of Merit.

VI. Case of Fire Lieutenant George F. Lee, Ladder Co. 3

on April 3, 1958, Holy Thursday, while off duty, Fire Lieutenant George F. Lee, Jr., of Ladder Co. 3 was attending services at the Holy Cross Cathedral. Noticing one of the officiating priests on the altar glance upward, he did likewise and saw what appeared to be a fire in the ceiling above the altar. He went to the rear of the church, requested that an alarm be sounded, secured a soda and acid extinguisher, climbed a flight of stairs to the choir loft and then proceeded up two spiral stairways to a ramp and a straight wooden ladder that led to a catwalk over the church proper. Proceeding down the catwalk to a point directly over the altar, Lieutenant Lee found a fire burning in planking directly beneath the walk. Flames were six to ten inches in height and had penetrated down through to the underside of the ceiling burning a hole about ten inches in diameter at this point.

Fire Lieutenant Lee, using extreme care so as not to dislodge burning material on the clergy below, discharged the contents of the extinguisher on the flames and successfully checked the fire. At this point, he heard the responding apparatus and went below to meet them and acquaint them with existing conditions.

Through his quick grasp of the situation and his immediate action involving strenuous physical effort on his part, Fire Lieutenant Lee not only prevented a very serious fire which could have quickly involved the whole cockloft, but also averted the possibility of a serious panic as the church was thronged with worshippers at the time of the incident.

Because of his fine judgment and quick action, the Fire Commissioner commended him highly in General Orders No. 16 of 1958.

The Board recommends that his name be placed on the Roll of Merit.

VII. Case of Fire Fighter Thomas J. Heanue, Engine Co. 1

At about 10:05 a.m., April 5, 1958, while Fire Fighter Thomas J. Heanue of Engine Co. 1 was getting into his car near his home on Savin Hill Avenue, he noticed a boy standing on a raft attempting to pull another boy aboard in the waters off 85 Morrissey Boulevard.

Fire Fighter Heanue ran approximately 200 feet to the water line, plunged into the icy water and swam to the raft which was about 100 feet offshore. When he arrived at the raft, he found one of the boys unconscious with his head resting on the raft while the rest of his body was under water. He lifted the boy onto the raft and pushed it toward Morrissey Boulevard.

Upon reaching the shore, Fire Fighter Heanue lifted the helpless boy from the raft toa position on land and performed artificial respiration until the boy was revived. The boy was then taken to the Boston City Hospital accompanied by a member of the Department who used a resuscitator enroute.

Because of the quick action of Fire Fighter Heanue, without regard for his own safety, the life of the boy was undoubtedly saved, and the Fire Commissioner commended him highly in General Orders No. 20 of 1958.

The Board recommends that his name be placed on the Roll of Merit.

VIII. Case of Fire Fighter Richard W. Lynch, Engine Co. 13

At 12:02 a.m., June 28, 1958, the Department responded to an alarm from Box 2217 for a fire in the building at 542 Shawmut Avenue.

Upon arrival of Engine Co. 13 at the scene, fire was coming from the windows of the front room on the second floor of the three-story dwelling. Members of the company advanced a line up the front stairs and were informed that there were children trapped in the burning apartment. As the door to the front room was opened, the line was operated on the fire which involved the room and furnishings. Meanwhile, Fire Fighter Richard W. Lynch of Engine Co. 13, without a mask, on hearing faint cries, groped his way into the front room which was heavily charged with heat, smoke and gases and then proceeded to a rear room which had not as yet been ventilated, in search of the children. He located a child on a bed and brought her to the apartment door where he handed her to smother member of Engine Co. 13. He then retraced his steps to the rear room and after groping around, he found a second child whom he removed from the building.

Because of the fact that Fire Fighter Lynch performed this rescue work under very hazardous conditions, and without regard for his own safety, the Fire Commissioner commended him highly in General Orders No. 32 of 1958.

The Board recommends that Fire Fighter Richard W. Lynch be awarded the "Walter Scott Medal."

IX. Case of Fire Fighter Henry J. Miller, Engine Co. 43

At 3:25 p.m., August 12, 1958, the Department responded to an alerm from Box 1816 for a fire in the building at 180 Monticello Avenue, Dorchester.

Upon arrival of the Department at the scene, a heavy smoke was issuing from the rear windows of the second floor of a seven-story apartment building. Members of Engine Co. 43 were informed by police officers present that an infant was trapped in the burning apartment. While other members of the company were advancing a line of hose up the stairway, Fire Fighter Henry J. Miller of Engine Co. 43 made his way to the second floor, and, without the aid of a gas mask, groped his way through the apartment which was heavily charged with heat, smoke and gases to the rear bedroom. Fire Fighter Miller located the infant in a crib, picked up the baby and made his way back and out to the stairway. The smoke here was so heavy that his vision was greatly limited, and he fell down the stairs, shielding the baby as he fell. At the bottom of the stairs, the baby was passed to a member of Ladder Co. 20. The infant was severely burned and was removed to the Boston City Hospital.

This rescue was accomplished before water could be applied to the fire, before ventilation could be effected, and after several previous attempts by occupants of the building to rescue the child had failed. As the result of his efforts, Fire Fighter Miller was partially overcome and was given first-aid treatment at the scene.

Because Fire Fighter Miller performed the rescue work under serious fire conditions, and without any thought of his own safety, the Fire Commissioner commended him highly in General Orders No. 41 of 1958.

The Board recommends that the name of Fire Fighter Henry J. Miller be placed on the Roll of Merit.

III. HIGH COMMENDATION

- 1. On February 21, 1959, at 4:04 a.m., Ladder Co. 4 responded on a still alarm, followed by Box 2251, for a fire in the building at 2476 Washington Street, Roxbury. Upon arrival of the company, fire was seen issuing from the second floor windows of the three-family dwelling house.
- Fire Lieutenant Paul J. O'Brien of Ladder Co. 4 was notified by a woman on the street that children were trapped on the second floor. He went up the stairway to the apartment and upon entering he found heavy smoke, heat, and fire conditions present. Hearing a voice at the end of the hallway to the rear of the building, he made his way toward this point and found a man who told him that some of his children were in a room next to the parlor, which was in the extreme front of the building. Lieutenant O'Brien groped his way back to this room and because of the smoke, heat and fire he had to crawl into the room. He found one child on the floor at the foot of a bed and brought him to the hallway where he passed him to a Fire Fighter. Lieutenant O'Brien again entered the room in a search for other children but an expolsion occurred which increased the intensity of the fire and he had to retreat.
- By this time members of Engine Co. 14 brought in a hose line and he directed them to operate a stream on the ceiling of the bedroom to cool the area. Lt. O'Brien re-entered the room and found a second child on the floor and passed this child out to the members of Engine Co. 14. About this time, clothing in a closet on the extreme left of the room became ignited and the light of the flames showed two children on the floor of the closet, one on top of the other. One of the children appeared to be breathing and the Lieutenent passed him to members of Engine Co. 14. He carried the other child from the room.
- Because of the extremely hazardous conditions present when Fire Lieutenant O'Brien performed the rescue work, without regard for his own safety (the entire parlor was burned out and fire had extended considerably into the bedroom), the Fire Commissioner is pleased to commend him highly and his name is referred to the Board of Merit for further consideration.
