FIRE PREVENTION WE.EK

1. Fire Prevention Week will be observed in the City of Boston from October 7 to 13, 1962, inclusive. Mayor John F. Collins has issued the following statement in connection with the observance of this week.

"Fire takes a life somewhere in the United States every forty-five minutes. Every hour of every day in this country approximately thirty-five dwellings burn. The mercantile and business establishments annually record fire losses that total into the millions. This tragic waste compounded unwittingly by the negligence or ignorance of its victims must be reduced by every means available to us. The enactment of safety legislation is the responsibility of the public, the observance of safety habits the responsibility of the individual.

"The City of Boston is again observing National Fire Prevention Week, October 7 to October 13. It is with pride that I note that for the first time in many years, Boston has experienced less than 2,000 building fires in one year. What is even more impressive is that this trend has been steadily downward for the past five years which is a positive indication of progress in our effort to give Boston a safe look as sell as a new look.

"As your Mayor, it is my sincere request that you as citizens maintain a high level of housekeeping in your homes and places of employment, give some serious thought to establishing a home emergency escape plan in the event of fire, and practice fire prevention all yearlong."

- 2. The Boston Fire Department will again emphasize the Fire Prevention Week with a series of activities as follows:
- (a) Fire stations shall be open to the public between the hours of 12 Noon and 8 p.m. for inspection of the premises and for the conveyance of information concerning the fire department functions and fire prevention matters. When citizens come to a station during Fire Prevention Week, the man on house patrol shall summon the commanding officer who should be available and ready to either show the visitors around the station and to answer questions regarding the department, or to have a suitable person assigned to this duty.
- (b) Fire Prevention literature will be passed out to children by the house patrol, but children will not be allowed to remain in quarters unless accompanied by a responsible adult.
- (c) Canvas signs giving notice that Fire Prevention Week is in progress should be displayed from fire stations. Most stations have these signs in their possession from exhibitions of previous years, and it is the responsibility of company officers to see to it that these signs are kept in good condition from year to year. Signs should be displayed from Sunday to Saturday. Signs shall be checked daily by the officer in charge of quarters to assure that they are firmly affixed to the building in a proper manner.

- 3. District Fire Chiefs are directed to take an active interest in fire prevention programs in the following manner:
- By making arrangements with the various plants and industrial enterprises within the district to hold fire drills during the week. By grading these drills as "Good," "Fair," or "Poor," and making a report of same to the Fire Prevention Division, indicating the name of the enterprise, the date of the drill and the grade. Same should be forwarded promptly. Each concern should be requested to acknowledge participation in Fire Prevention Week activities via written correspondence. These drills should be conducted by a company officer after arrangements are made. At plants where there are special or company fire brigades, particular attention should be given to assignments and/or response procedures. It is requested that the name of the company officer conducting the drill be furnished. It is anticipated that not less than three drills be conducted in each district.
- (b) All public and private schools within each district shall be visited by a district chief or duly delegated company officer. School fire drills shall be held during Fire Prevention Week in all schools, both public and private. Permission should be obtained for the presentation of a five-minute talk on the subject of fire prevention such addresses should not be read from a printed manuscript. Every effort should be made to speak effectively and emphatically.
- 4. The School Department in cooperation with the Fire Department is going to distribute "Home Inspection Blanks." Distribution of these blanks shall be by company officers within whose sub-districts the schools are located, and they shall be distributed during Fire Prevention Week. The teachers shall collect the completed blanks from the pupils, and in turn the company officers will collect from the various schools and return these blanks to the Fire Prevention Division with a summary of schools and total numbers collected on or before November 1. Posters for bulletin boards, two for each school, will also be distributed.

An essay contest is being conducted in all parochial and public schools in the City for the sixth grade of the grammar schools. The topic is "When Fire Strikes - The Plan of Escape From My Home." The essay is to be of 150 words or less. All officers and members are requested to show an interest in this essay contest and to answer questions concerning it to any student who may request information relative to Fire Prevention in order to complete his essay.

5. The district fire chief should compile a list of fraternal, social, civic and professional organizations within the district and advertise to them the willingness of the Fire Department to provide company officers for the purpose of lecturing on Fire Prevention at any time. District fire chiefs should make a concerted effort to bring the activities of the department before these organizations and arrange for lectures to be given. The name of any organization so participating should be reported to Fire Prevention Division, specifically, if the organization can be urged to forward on their own stationery a notation of the event, it would be to the greater advantage of the Fire Department.

- Throughout the week, all fire fighters are to wear the department uni-6. form going to and from the fire stations, even though they may be driving their cars. The uniforms shall be neat and clean and regulation blue shirts and black ties shall be worn in conjunction therewith. Fire fighters are to pay special attention to the observance of fire hazards and to the duty of observing and locating fire hazards along the route followed by them in their coming to and going from daily work. Dilapidated buildings, rubbish accumulations, and other hazards should be reported to the Fire Prevention Division. The public expects uniformed members of the Fire Department to know something about fire prevention work and to have an interest in this subject since they are public employees engaged in this field. Fire fighters, therefore, during Fire Prevention Week should have this subject uppermost in their minds, and they should not pass by a fire hazard at any time without making a note of it for reference to the Fire Prevention Division. In short, every uniformed man in the Fire Department is a fire prevention inspector at all times.
- 7. Company commanders, upon receipt of the Governor's Proclamation on Fire Prevention and Fire Prevention posters, will post these items in a suitable location at the front of each fire station where they will be visible to the public. They will remain posted until October 14, 1962.
