1. It is with deep regret that the Fire Commissioner announces the death on January 5, 1965 of Fire Fighter Walter D. Kripp of Ladder Co. 22. Fire Fighter Kripp was appointed to the department on October 21, 1942.
2. The funeral was held from the John A. Sawyer Funeral Home, 329 Bunker Hill Street, Charlestown, at 8:10 a. m., Saturday, January 9, 1965, followed by a Solemn High Mass of Requiem in St. Mary's Church, Warren St., Charlestown at 9 a. m.
3. The Chief of Department made the customary detail to act as funeral escort, and members of Ladder Co. 22 were excused from duty in order to attend the funeral services.

II. MARCH OF DIMES

1. His Honor, Mayor John F. Collins, has appointed Acting City Collector-Treasurer Edward W. Holmes to be Chairman of the City employees' drive for the 1965 March of Dimes Campaign. His Honor the Mayor is deeply interested in the success of the campaign inasmuch as he knows from personal experience the tragedy that the onslaught of polio can bring upon a family.
2. During the past year the National Foundation has spent thousands of dollars in Suffolk County on old polio cases for hospitalization, physical therapy, orthopedic appliances, physical checkups, etc. Since the 1955 epidemic, there have been over one thousand new cases of polio, causing an expenditure of over one million dollars.
3. This appeal is part of a nationwide effort to fight polio and other viruses, arthritis, birth defects, and disorders of the central nervous system. Volunteer contributions are being solicited and members of the Fire Department are requested to respond generously to this appeal as they have done in the past.
4. Members contributing should place their names and addresses on the stub end of the pledge card, which is being issued with this order, and also the amount being contributed. The company commander, or other person collecting the money, shall give the large portion of the card to the person contributing as his or her receipt.
5. Company numbers should be placed on the front right-hand corner of the stubs which are to be returned with the money to Principal Clerk and Stenographer Mary E. Hourihan in the Headquarters Division. Contributions and stubs will be received from 9 a. m. to 12 Noon each weekday except Saturday, and all contributions should be delivered before January 29, 1965.

2. Upon arrival of Ladder Co. 4 at the scene of the fire, heavy smoke was emanating from second floor windows. Members of the company ascended the front stairs and forced the door into the second floor apartment which was involved in fire. Fire Fighters James J. Coakley and Vincent P. Hurley of Ladder Co. 4 crawled on the floor through the burning living room and into rear bedrooms where each man found a child whom he carried back through the living room to the front hallway.

3. Upon arrival of Engine Co. 12, Fire Fighter Edward C. Donovan, Jr., ascended a ladder, squeezed through a narrow window and found a third child in a rear bedroom of the apartment involved in fire. Realizing that there was insufficient room to make his exit back through the same window, he carried the child through the burning living room to the front hallway.

4. All three rescues were made prior to the operation of hose lines, without the use of gas masks, and when only limited ventilation had been effected. The foregoing men performed the rescue work at considerable risk to their persons and without thought of their own safety.

## VI. HIGH COMMENDATIONS

1. At 8:38 a. m., March 4, 1965, the department responded to Box 1787, two alarms, for a fire in the dwelling house at 242 Magnolia St., Dorchester.

Upon arrival at the fire, members of Ladder Co. 7 were directed by the District Fire Chief to check the building and to evacuate any people that might be trapped in the building. The asphalt shingle siding on the exterior of the building was fully involved by fire in the rear from the first floor to the roof, generating heavy smoke and exit by way of the rear stairs was cut off. All three apartments were heavily charged with smoke, heat and gases.

Fire Lieutenant Walter J. Cameron and Fire Fighter Arthur E. Ruggere of Ladder Co. 7 observed a woman and a baby at a window of the building on the left rear side of the third floor. They went over the front stairs to the third floor and groped their way to the rear left side of the building to a room adjacent to the one involved in fire, and they found a mother and a two-week old baby, carried them along the hallway and down the front stairs to the street where oxygen was administered to the mother and baby. Both were removed to the Boston City Hospital.

This rescue work was performed before adequate ventilation had been completed and while hose lines were being run to the fire.

Because of the fact that Fire Lieutenant Cameron and Fire Fighter Ruggere performed the rescue work without thought of their own safety and at great personal risk, the Fire Commissioner is pleased to commend them highly, and their cases are referred to the Board of Merit for further consideration.

III. HIGH COMMENDATIONS

1. At 10:45 p. m., March 27, 1965, the department responded to Box 7415 (3 alarms) for a fire at Marion Manor, a home for elderly people, located at 40 Old Harbor Street, South Boston.

2. Upon arrival of Engine Co. 1, the first company at the location, members brought a line over the stairway to the fourth floor where there was a severe concentration of heat, smoke and gases. Fire Fighter Thomas S. Lydon of that company, upon hearing moaning from somewhere ahead, left the other members with the line and groped his way forward in the direction of the sound. After covering some distance, he came upon an unconscious man lying on the floor of the hallway. He dragged the man back towards the door leading to the stairway where other members brought him to the street.

3. Fire Lieutenant Richard A. Kemp of Engine Co. 43 and Fire Fighter Charles E. Gaul of Engine Co. 1 were assisting in the advance of the hose line of Engine 43 and upon reaching the fourth floor they heard moaning. They groped their way down the hallway to a room where Fire Lieutenant Kemp found an unconscious man on a bed. In the meantime, Fire Fighter Gaul entered another room off the hallway and found a man leaning out a window. They removed both victims to the stairway and thence to the street.



4. Fire Fighters Henry J. Miller and James J. Mahon of Engine Co. 43, who were assisting in the running of a 2 1/2" line over the stairway to the fourth floor, also heard moaning coming from one of the rooms on that floor. They groped their way down the hallway and found two unconscious men in the room. One man was sitting in a chair and the other was lying unconscious on the floor. Fire Fighter Miller aided in placing one man on the shoulders of Fire Fighter Mahon who carried him out of the building. Fire Fighter Miller was unable to lift the other man and dragged him out of the room, along the corridor and to the stairway where other members assisted in removing him to the street.

5. Fire Fighters Charles P. McNally and Francis X. McDonnell of Ladder Co. 19 went over a ladder to the fourth floor, accompanied by Fire Capt. Thomas F. Bohan of that company. Fire Fighters McNally and McDonnell entered through a window into a room where they found the occupant. They brought him to the ladder where Fire Captain Bohan removed him to the street.

6. All the foregoing rescue work was performed without the aid of gas masks, before hose lines were placed in operation, and before ventilation had been accomplished. All members concerned in the rescue work suffered severely from inhalation of smoke and heat and physical exhaustion.

7. The Fire Commissioner is pleased to commend highly the following-named members of the department who performed their duty with complete disregard for their own safety, and their cases are referred to the Board of Merit for further consideration:

Presentation will be made to the next of kin of the deceased Fire Fighter by the Mayor of Boston on recommendation of the Fire Commissioner.

3. The medal depicts, on the front side, the Angel of Death guiding the Fire Fighter to his reward in heaven. On the reverse side, surrounded by a wreath, will be engraved the man's name, date of appointment to the department, his last assignment, the number of the box and the date of the incident resulting in the member's death.

4. The medal will be encased within a frame, under glass, backed by an engrossed parchment bearing the member's history within the department and giving information concerning the manner in which he met his death. At the bottom of the parchment, under the medal, the following impressive inscription (modified for the individual) from the pen of the late Henry Gillen, a prominent Boston newspaperman, shall appear:

"All honor unto gallantry  
In reverence we pay  
That others might have days to be  
He gave his life away  
Now glory shall enshrine his name  
And time his deeds defy  
Since humble men who sought no fame  
Have taught us how to die"

#### VI. APPRECIATION

At this time, the Fire Commissioner wishes to express to Fire Fighter Robert G. Brady of Ladder Co. 4, Fire Fighter Harold A. Carle of Ladder Co. 30, and Murray Young, a civilian in no way connected with the Department, but one of our most loyal supporters, the sincere thanks of the Department for their efforts in the execution of the "Medal and Citation of Valor."

These three men gave unstintingly of their own time, effort, and artistic talent for this endeavor. We are truly very grateful to them and feel that their names should be recorded for posterity. Therefore, their names will be recorded in the 1965 Annual Report of the Boston Fire Department as the men responsible for executing the Medal and Citation.

BOARD OF MERIT

The Board of Merit, consisting of the Chief of Department, the Chief of Staff, the Assistant Fire Chief, and the Deputy Fire Chiefs, has considered all meritorious acts referred to it for the year, 1964. After careful consideration and study, the Board submitted the following recommendations which are hereby approved by the Fire Commissioner:

1. Case of Fire Fighter Francis A. Kane, Ladder Co. 3

At 8:43 a. m., January 15, 1964, the department responded to an alarm from Box 1642 for a fire in the dwelling house at 254 Shawmut Avenue. Upon arrival of Ladder Company 3 at the scene, fire and heavy smoke were issuing from windows on the third floor, and a man and woman were seen leaning from a window on this floor.

The members of Ladder Company 3 raised a forty-foot ladder to the window where the people were seen, and Fire Fighter Francis A. Kane of that company ascended the ladder, pulled the man out of the window onto the ladder where he was assisted to the ground by other fire fighters. The woman refused to be taken down the ladder and fell backwards into the room. Fire Fighter Kane entered the room and after a struggle was able to place the woman on his shoulders and carry her to a stairway and down three flights to the street, where she was removed to the Boston City Hospital. The room from which she was rescued, and the stairway were heavily charged with heat, smoke and gases, and the rescue work was performed before complete ventilation was accomplished and while hose lines were being laid. Fire Fighter Kane suffered from severe exhaustion, but he refused to go to the hospital and was given first aid at the scene.

Because of the fact that the rescue work was performed by Fire Fighter Kane under most difficult conditions and without thought of his own safety, the Fire Commissioner commended him highly in General Orders No. 3 of 1964.

The Board recommends that the name of Fire Fighter Francis A. Kane of Ladder Company 3 be placed on the Roll of Merit.

2. Case of Fire Lieutenant Leo J. Fama of Engine Company 21

At 12:33 p. m., February 19, 1964, the department responded to a still alarm, followed by Box 2236 (4 alarms) for a fire at 6-6A Sumner Place, Roxbury.

Upon arrival of Engine Squad 14, members of that company assisted occupants from the building. A woman informed Fire Lieutenant Leo J. Fama of Engine Co. 21, who was detailed to Engine Squad 14, that her four-year old child was still in a crib on the third floor of the building. Fire Lieutenant Fama went over the front stairs to the third floor, broke open a locked door, went to a rear

bedroom, found the child and returned to the street by way of the stairway and turned the child over to her mother.

Fire Lieutenant Fama performed the rescue work under severe conditions of heat and smoke, without the protection of gas mask and hose lines. It appears that by his prompt action, Fire Lieutenant Fama saved the life of the child, as moments after he had removed her from the building, an explosion occurred and fire enveloped and gutted the third floor.

Because of the great risk to which he exposed himself, without regard for his own safety, the Fire Commissioner commended him highly in General Orders No. 10 of 1964.

The Board recommends that Fire Lieutenant Leo J. Fama of Engine Company 21 be awarded the John E. Fitzgerald Medal for Most Meritorious Act.

3. Case of Fire Lieutenant John E. Campbell of Ladder Company 15

At 2:05 a. m., March 23, 1964, the department responded to Box 1584, 3 alarms, for a fire in an apartment building at 384 Commonwealth Ave., Boston.

During the fire, two women were seen at a window on the top floor of the six-story building directly over the fire which was burning on two lower floors. Due to the layout of the courtyards, an aerial ladder could not be raised to the floor, which was out of reach of ground ladders.

Fire Lieutenant John E. Campbell and Fire Fighter Robert F. Murphy of Ladder Company 15 entered the building and ascended to the sixth floor via the front stairway. They encountered heavy smoke and heat on the stairs at the fifth and sixth floors as at this time there were no hose lines in operation above the fourth floor. On the sixth floor they groped their way down a long hall and entered a number of small rooms before they were able to locate the two women, who were near collapse and hanging out of a window to escape the severe heat and smoke. Fire Lieutenant Campbell and Fire Fighter Murphy each carried a victim down the stairway. Upon reaching the street, Fire Fighter Murphy collapsed and was taken to the Boston City Hospital along with the two rescued persons who were in critical condition from inhalation of heat and smoke. Fire Lieutenant Campbell received oxygen at the scene.

Because of the fact that the rescue work was accomplished by Fire Lieut. Campbell under very hazardous conditions and without thought of his own safety, the Fire Commissioner commended him highly in General Orders No. 11 of 1964.

The Board recommends that Fire Lieutenant John E. Campbell of Ladder Company 15 be awarded the Walter Scott Medal for Valor.



4. Case of Fire Fighter Robert F. Murphy of Ladder Company 15

At 2:05 a. m., March 23, 1964, the department responded to Box 1582, 3 alarms, for a fire in an apartment building at 384 Commonwealth Ave., Boston.

During the fire, two women were seen at a window on the top floor of the six-story building directly over the fire which was burning on two lower floors. Due to the layout of the courtyards, an aerial ladder could not be raised to the floor, which was out of reach of ground ladders.

Fire Lieutenant John E. Campbell and Fire Fighter Robert F. Murphy of Ladder Company 15 entered the building and ascended to the sixth floor via the front stairway. They encountered heavy smoke and heat on the stairs at the fifth and sixth floors as at this time there were no hose lines in operation above the fourth floor. On the sixth floor they groped their way down a long hall and entered a number of small rooms before they were able to locate the two women, who were near collapse and hanging out of a window to escape the severe heat and smoke. Fire Lieutenant Campbell and Fire Fighter Murphy each carried a victim down the stairway. Upon reaching the street, Fire Fighter Murphy collapsed and was taken to the Boston City Hospital along with the two rescued persons who were in critical condition from inhalation of heat and smoke.

Because of the fact that the rescue work was accomplished by Fire Fighter Murphy under very hazardous conditions and without thought of his own safety, the Fire Commissioner commended him highly in General Orders No. 14 of 1964.

The Board recommends that Fire Fighter Robert F. Murphy of Ladder Company 15 be awarded the Patrick J. Kennedy Medal of Honor.

5. Case of Fire Fighter William H. Irvine of Ladder Company 7

At 10:02 p. m., April 8, 1964, the department responded to an alarm from Box 3151 for a fire in the dwelling house at 22 Draper Street, Dorchester.

Upon arrival at the scene, the members of Ladder Company 7 found the first floor front fully involved in fire, with fire coming out the front and side windows and also extending up the stairway to the second floor.

Fire Fighter William H. Irvine of Ladder Company 7, upon being informed that a woman and child were still in the building, ascended a ladder to the second floor rear and entered a bedroom. He made his way along a hallway into a second bedroom where he found the child. Being unable to bring the child down the front stairway because of fire and smoke, he made his way to the rear of the house and down the ladder to the ground.

Fire Fighter Irvine performed this rescue work under severe conditions of heat and smoke, before ventilation had been completed and while hose lines were being laid.



Because the foregoing rescue work was performed at considerable risk and without thought of his own safety, the Fire Commissioner commended him highly in General Orders No. 19 of 1964.

The Board recommends that the name of Fire Fighter William H. Irvine of Ladder Company 7 be placed on the Roll of Merit.

6. Case of Fire Fighter Thomas J. Callaghan of Engine Company 22

At 3:07 p. m., July 10, 1964, the department responded to an alarm from Box 1556 for a fire in the four-story dwelling house at 182 West Brookline Street, Boston. Upon arrival at the scene, the members were informed that a child was trapped on the top floor of the building where smoke was showing.

Fire Fighter Thomas J. Callaghan of Engine Company 22 went over the front stairway to the top floor which was heavily charged with smoke and heat. He crawled down a corridor past the fire area and into a front bedroom. He ventilated the room by breaking windows with his fire helmet. He then found a thirteen-month old infant, removed it from its crib and carried the child down the stairway to safety.

The rescue work was carried out before ventilation had begun or hose lines were in operation, and the prompt action of Fire Fighter Callaghan in all probability saved the child's life.

Because he exposed himself to great danger, without thought of his own safety, the Fire Commissioner commended him highly in General Orders No. 29 of 1964.

The Board recommends that the name of Fire Fighter Thomas J. Callaghan of Engine Company 22 be placed on the Roll of Merit.

7. Case of Fire Fighter Joseph H. Hardiman of Ladder Company 3

At 8:25 a. m., September 4, 1964, the department responded to an alarm from Box 1671 for a fire in the dwelling house at 53 Newland Street.

Upon arrival at the fire, members of Ladder Company 3 were informed by District Fire Chief Michael Galvin of District 4 that a woman was trapped on the third floor of the building which was involved in fire and heavily charged with smoke. A ladder was raised to a third-floor window, and Fire Fighters Joseph H. Hardiman and John M. Morrissey of Ladder Co. 3 ascended the ladder and entered the third floor to search for the trapped woman. They found her unconscious on the floor and discovered at that time that she was a cripple. With great difficulty, the two fire fighters carried the woman to the ladder and down the ladder to the street.

Fire Fighters Hardiman and Morrissey performed the rescue work before the building could be properly ventilated and before hose lines could be brought into operation on the fire. Inasmuch as neither fire fighter was wearing

a gas mask, both of them endured great physical punishment due to exposure to smoke, heat and gases.

Because of the fact that the rescue work was performed at great personal risk and without thought of his own safety, the Fire Commissioner highly commended Fire Fighter Hardiman in General Orders No. 37 of 1964.

The Board recommends that the name of Fire Fighter Joseph H. Hardiman of Ladder Company 3 be placed on the Roll of Merit.

8. Case of Fire Fighter John M. Morrissey of Ladder Company 3

At 8:25 a. m., September 4, 1964, the department responded to an alarm from Box 1671 for a fire in the dwelling house at 53 Newland Street.

Upon arrival at the fire, members of Ladder Company 3 were informed by District Fire Chief Michael Galvin of District 4 that a woman was trapped on the third floor of the building which was involved in fire and heavily charged with smoke. A ladder was raised to a third-floor window, and Fire Fighters Joseph H. Hardiman and John M. Morrissey of Ladder Co. 3 ascended the ladder and entered the third floor to search for the trapped woman. They found here unconscious on the floor and discovered at that time that she was a cripple. With great difficulty, the two fire fighters carried the woman to the ladder and down the ladder to the street.

Fire Fighters Hardiman and Morrissey performed the rescues before the building could be properly ventilated and before hose lines could be brought into operation on the fire. Inasmuch as neither fire fighter was wearing a gas mask, both of them endured great physical punishment due to exposure to smoke, heat and gases.

Because of the fact that the rescue work was performed at great personal risk and without thought of his own safety, the Fire Commissioner highly commended Fire Fighter Morrissey in General Orders No. 37 of 1964.

The Board recommends that the name of Fire Fighter John M. Morrissey of Ladder Company 3 be placed on the Roll of Merit.

## VIII. HIGH COMMENDATIONS

1. At 8:41 a. m., April 23, 1965, the department responded to Box 2314 for a fire in the apartment house at 879 Beacon Street.

Upon arrival of Ladder Company 15, District Fire Chief William Kennealey ordered the company to get a ladder to the fifth floor window on the alley side of the building where a woman was trapped and threatening to jump because of extreme heat and heavy smoke.

While Ladder 15 was being maneuvered into a position where the aerial ladder could be used, Fire Fighter George E. Thompson of Ladder Company 15 climbed to the top of a fifty-foot ladder which was at approximately a 90 degree angle and several feet short of the window. From his position he calmed the woman and kept her from jumping. In the meantime, the aerial ladder was raised to the fifth floor at about a 45 degree angle, despite the interference of a fire escape on an adjoining building. Fire Fighter Thompson climbed from the top of the fifty-foot ladder onto the tip of the aerial ladder, assisted the woman out of the window, onto the ladder and down to safety.



Fire Fighter Thompson performed this rescue work under very difficult conditions and without thought of his own safety. The Fire Commissioner, therefore, is pleased to commend him highly, and his name is referred to the Board of Merit for further consideration.

2. At 4:53 p. m., April 15, 1965, the department responded to Box 1761, two alarms, for a fire in a three-family wooden house at 28 Southwood Street, Roxbury, which fire was extending to the house at 62 Edgewood Street.

Upon arrival of Engine Company 12, the members were informed by police of Division 9 that children were trapped on the third floor at 28 Southwood Street and that they were unable to rescue them because of the fire, heat and smoke which filled the stairwell. One police officer was treated at the City Hospital as a result of his rescue attempt.

Fire Fighters Fred I. Smith and William P. Kenney of Engine Company 12 proceeded over the front stairs, passing through the heavy smoke, gases and heat coming from the second and third floor porches and kitchens and began a search for the children. The third floor was heavily charged with smoke, and they groped from room to room until Fire Fighter Smith found a child unconscious on the floor of a front bedroom. He removed the child to the street via the front stairway. Fire Fighter Kenney also found an unconscious child in the front bedroom. He passed the child to members of Ladder Company 4 who had by this time raised a ladder to the third-floor window. Fire Fighter Smith again entered the building and proceeded to the third floor where he found another child wedged between a wall and a bureau. He removed the second unconscious child to the street and aided in administering oxygen to this child while en route to the Boston City Hospital.

The rescue work was performed before any ventilation work had been done or hose lines were in operation.

Because Fire Fighters Smith and Kenney performed this duty at great risk to their persons and without thought of their own safety, the Fire Commissioner is pleased to commend them highly, and their cases are referred to the Board of Merit for further consideration.

EMERGENCY SIGNAL

1. Effective immediately, Emergency Signal 10-18 is established within this department and shall be added to Card Q of the Instruction Cards.
2. When this signal is received over Fire Department tapper, it indicates that a "Riot Condition" exists. In most cases this signal will be followed by the nearest fire alarm box to the scene of the incident. When this signal is received followed by the box, it indicates that the first alarm apparatus will respond in the usual manner to the location and will also alert the entire department that a "Riot Condition" exists. ("Riot Condition" defined as three or more persons assembled together in doing some lawful or unlawful act in a violent or tumultuous manner causing great terror to the public).
3. If, upon arrival at the scene, a fire is in progress, the department will go to work in the usual manner to contain the fire. The officer in charge will seek necessary assistance from the police for the protection of department personnel.
4. If no fire exists upon arrival, the officer in charge will report to the superior officer in charge of the police at the location and be governed by his instructions as to the deployment of fire department personnel. In the event that more assistance is needed at a location as outlined above, multiple alarms will be sounded in a similar manner as first alarms with the necessary prefix denoting the multiple alarm, and apparatus response will be in accordance with the regular running card assignment. The Deputy Chief on duty as well as the Assistant Fire Chief assigned to respond during that period will respond to the scene and coordinate the operations of the department.
5. The lighting plant shall respond in each instance during the hours of darkness when this emergency signal is struck.
6. There may be instances where a still alarm of apparatus is requested by the Police Department to handle minor incidents or to assist the police in some manner. In these instances, the Fire Alarm Office, in addition to notifying the still alarm companies, will transmit this information to the district fire chief.
7. In addition, the Fire Commissioner and Chief of Department will be notified when any of the above conditions exist.

## VII. HIGH COMMENDATION

1. At 1:47 a. m., August 31, 1965, the department responded to an alarm from Box 2132 for a fire in the dwelling house at 19 Greenville Street, Roxbury, for which subsequently two alarm were sounded.

Upon arrival of Ladder Co. 4, two occupants of the building were seen on a second-floor porch roof. A twenty-foot ladder was raised, and Fire Fighter Arthur Glover removed the persons from the roof. They notified him that another man was still trapped in the building.

Fire Fighter Glover again ascended the ladder and entered the building which by now was heavily charged with heat and smoke. He groped through two rooms on his hands and knees and found an unconscious man whom he dragged back to the window with considerable difficulty. During this rescue, Fire Fighter Glover suffered severely from smoke inhalation. He passed the victim to Fire Fighter Fleming of Ladder Co. 4 who carried him to the ground.

The rescue work was completed by Fire Fighter Glover without the use of a gas mask and before ventilation had been effected or before hose lines were run.

2. Inasmuch as Fire Fighter Glover performed the foregoing rescue work without thought of his own safety and at great risk to his person, the Fire Commissioner is pleased to commend him highly, and his case is referred to the Board of Merit for further consideration.

#### VIII. LETTER OF COMMENDATION

M., I was summoned to administer the Last Rites of the Catholic Church to the occupant of an automobile involved in a serious accident in front of the Archbishop's Residence on Commonwealth Avenue. It was a fatal accident, the worst I have ever witnessed.

"My purpose in writing to you is to commend most highly the men of Engine Squad 29 under Captain Raymond Frazel and the men of Ladder 11 of the Boston Fire Department, who responded to this emergency. These men worked feverishly, yet most efficiently to extricate the victims of this accident. Their work enabled me to administer the sacraments to the victims and to offer them spiritual consolation.

FIRE PREVENTION WEEK

1. Fire Prevention Week will be observed in the City of Boston from October 3 to October 9, 1965, inclusive. Mayor John F. Collins has issued the following statement in connection with the observance of this week.

"Fire Prevention is the joint effort of the citizens of a city and its fire department. The results of this mutual endeavor is reflected by the lessening of the fire losses and by the abating of loss of life and injury from fire.

"This does not just happen as a matter of course. It is with unconcealed pride that I look to the efforts of the Boston Fire Department in the field of fire prevention. The activity of this department in our municipal structure is directed to the day-by-day education of the public in fire safety starting with the school children and continuing through adulthood to the control and regulation of those materials and substances which, by their very nature, present a hazard to the public and to the research program in which they participate. All these make very sound basis of fire prevention as evident by the action of the Massachusetts Legislature in outlawing, effective July 1, 1965, the use of space heaters, vented and unvented, in the Commonwealth. This was a direct result of the research activity of the Boston Fire Department. It has been conservatively estimated that the fire department's support in this matter has resulted in the saving of better than fifteen lives a year in this City - project this to the Commonwealth, and the good effect it has had on other cities in the New England Complex, and you can see that the savings in lives stemming from this fire prevention fundamental of the Boston Fire Department is responsible for saving hundreds of lives each year in the New England area alone.

"We cannot rely on this success for our future fire safety. We must keep pace with industry, and we must understand the psychology of men and emphasize the need for fire safety. Only in this way can we cope with the unanticipated, undreamed of, and unconsidered hazards associated with fire, for it is only with this awareness that we assure the safety of ourselves and others."

2. The Boston Fire Department will again emphasize the Fire Prevention Week with a series of activities as follows:

(a) Fire stations shall be open to the public between the hours of 12 Noon and 8 p. m. for inspection of the premises and for the conveyance of information concerning the fire department functions and fire prevention matters. When citizens come to a station during Fire Prevention Week, the man on house patrol shall summon the commanding officer who should be available and ready to either show the visitors around the station and to answer questions regarding the department, or to have a suitable person assigned to this duty.



(b) Canvas signs giving notice that Fire Prevention Week is in progress should be displayed from fire stations. Most stations have these signs in their possession from exhibitions of previous years, and it is the responsibility of company officers to see to it that these signs are kept in good condition from year to year. Signs should be displayed from Sunday to Saturday. Signs shall be checked daily by the officer in charge of quarters to assure that they are firmly affixed to the building in a proper manner.

3. District Fire Chiefs are directed to take an active interest in fire prevention programs in the following manner:

(a) By making arrangements with the various plants and industrial enterprises within the district to hold fire drills during the week; by grading these drills as "Good," "Fair," or "Poor," and making a report of same to the Fire Prevention Division, indicating the name of the enterprise, the date of the drill and the grade. Same should be forwarded promptly. Each concern should be requested to acknowledge participation in Fire Prevention Week activities via written correspondence. These drills should be conducted by a company officer after arrangements are made. At plants where there are special or company fire brigades, particular attention should be given to assignments and/or response procedures. It is requested that the name of the company officer conducting the drill be furnished. It is anticipated that not less than three drills be conducted in each district.

(b) All public and private schools within each district shall be visited by a district chief or duly delegated company officer. School fire drills shall be held during Fire Prevention Week in all schools, both public and private. Permission should be obtained for the presentation of a five-minute talk on the subject of fire prevention - such addresses should not be read from a printed manuscript. Every effort should be made to speak effectively and emphatically.

4. The School Department in cooperation with the Fire Department is going to distribute "Home Inspection Blanks." Distribution of these blanks shall be by company officers within whose subdistricts the schools are located, and they shall be distributed during Fire Prevention Week. The teachers shall collect the completed blanks from the pupils, and in turn the company officers will collect from the various schools and return these blanks to the Fire Prevention Division with a summary of schools and total numbers collected on or before November 1. Posters for bulletin boards, two for each school, will also be distributed.

An essay contest is being conducted in all parochial and public schools in the City for the sixth grade of the grammar schools. Topic is "How I Practice Fire Prevention." The essay is to be of 150 words or less. All officers and members are requested to show an interest in this essay contest and to answer questions concerning it to any student who may request information relative to Fire Prevention in order to complete his essay.



5. The district fire chief should compile a list of fraternal, social, civic and professional organizations within the district and advertise to them the willingness of the Fire Department to provide company officers for the purpose of lecturing on Fire Prevention at any time. District fire chiefs should make a concerted effort to bring the activities of the department before these organizations and arrange for lectures to be given. The name of any organization so participating should be reported to Fire Prevention Division, specifically if the organization can be urged to forward on their own stationery a notation of the event, it would be to the greater advantage of the Fire Department.

6. Throughout the week, all fire fighters are to wear the department uniform going to and from the fire stations, even though they may be driving their cars. The uniforms shall be neat and clean and regulation blue shirts and black ties shall be worn in conjunction therewith. Fire fighters are to pay special attention to the observance of fire hazards and to the duty of observing and locating fire hazards along the route followed by them in their coming to and going from daily work. Dilapidated buildings, rubbish accumulations, and other hazards should be reported to the Fire Prevention Division. The public expects uniformed members of the Fire Department to know something about fire prevention work and to have an interest in this subject since they are public employees engaged in this field. Fire fighters, therefore, during Fire Prevention Week should have this subject uppermost in their minds, and they should not pass by a fire hazard at any time without making a note of it for reference to the Fire Prevention Division. In short, every uniformed man in the Fire Department is a fire prevention inspector at all times.

7. Company commanders, upon receipt of the Governor's Proclamation on Fire Prevention and Fire Prevention posters, will post these items in a suitable location at the front of each fire station where they will be visible to the public. They will remain posted until October 10, 1965.

After attending to this, he will position his hose wagon adjacent to the three-way inlet which is located just outside the tunnel portal as previously described. This places him in a position to receive and connect any lines that may be laid, if conditions require, to supplement the tunnel fire line. The pump of Engine Co. 25 shall proceed to the tunnel and lay the necessary line or lines from the available 2 1/2" gated outlets.

I. OPERATING PROCEDURE FOR SUMNER AND  
CALLAHAN TRAFFIC TUNNELS  
(Sumner Traffic Tunnel)

In the event of a fire or accident in the Sumner Traffic Tunnel, Box 123 will be transmitted. The Fire Department response will be Engine Companies 8, 9, 25 and 11; Ladder Companies 1 and 2; Rescue Company, Districts 1 and 3. Inasmuch as the flow of traffic in this tunnel is one-way from East Boston to Boston, a fire or accident in the tunnel will in all probability prevent the movement of traffic beyond the point of the incident. Therefore, the tunnel employees will stop the flow of traffic into the tunnel from the East Boston side and direct all vehicles ahead of the incident to move into the right-hand lane and proceed out of the tunnel, thus leaving the left-hand lane open for fire apparatus entering from the Boston side. The open lane will be located on the fire line side of the tunnel, providing ready access to outlets.

Engine Company 8 is the first due engine company on the Boston side. The hose wagon will stop at the Sumner Traffic Tunnel exit ramp to permit members of Ladder Company 1 to get on the hose wagon with forcible entry tools and proceed into the tunnel in the open lane. Extreme caution should be used to avoid an accident with an oncoming vehicle, which may have not moved over sufficiently into the right-hand lane. The District Fire Chief of District 3 shall also proceed into the tunnel. All other apparatus responding on the Boston side shall stand by outside the tunnel. In the event additional personnel or apparatus is needed, request for same can be made via tunnel telephone to the tunnel Administration Building, relayed to the Fire Alarm Office by tunnel personnel, and then to the companies through Fire Alarm Office by radio. The companies and District Fire Chief responding from East Boston shall stand by outside the tunnel on the East Boston side awaiting orders.

During the winter season when the fire line in the Sumner Traffic Tunnel is drained to prevent freezing, one man from Ladder Company 1 shall proceed on foot to the Boston Ventilation Building at 308-328 North Street and open valve; and Engine Company 40 shall respond to East Boston Ventilation Building at 55-65 Liverpool Street and open valve. These valves are in manholes with covers painted RED. Signs marked FIRE VALVE are placed on buildings to indicate manhole locations.

(Callahan Traffic Tunnel)

In the event of a fire or accident in the Callahan Traffic Tunnel, Box 124 will be transmitted. The Fire Department response will be Engine Companies 8, 9, 25 and 11; Ladder Companies 1 and 2; Rescue Company; and Districts 1 and 3. Inasmuch as the flow of traffic in this tunnel is one-way from Boston to East Boston, a fire or accident in the tunnel will in all probability prevent the movement of traffic beyond the point of the incident. Therefore, the tunnel employees will stop the flow of traffic into the tunnel from the Boston side and direct all vehicles ahead of the incident to move into the right-hand lane and proceed out of the tunnel, thus leaving the left-hand lane open for fire apparatus entering the



East Boston side. The open lane will be located on the fire line side of the tunnel, providing ready access to outlets.

Engine Company 9 is the first due engine company on the East Boston side. This company (a single unit pump) will stop at the Callahan Traffic Tunnel exit ramp to permit members of Ladder Company 2 to get on the pump with forcible entry tools and proceed into the tunnel in the open lane. Extreme caution should be used to avoid an accident with an oncoming vehicle which may have not moved over sufficiently into the right-hand lane. The District Fire Chief of District 1 shall also proceed into the tunnel. All other apparatus responding on the East Boston side shall stand by outside the tunnel. In the event additional personnel or apparatus is needed, request for same can be made via tunnel telephone, relayed to the Fire Alarm Office by tunnel personnel, and then to the companies through Fire Alarm Office by radio. The companies and the District Fire Chief responding from Boston shall stand by outside the tunnel on the Boston side awaiting orders.

Water in Callahan Traffic Tunnel is not subject to freezing and is not shut off during winter season, except the Callahan Tunnel Ramp, from Cross Street to Boston Portal; Callahan Tunnel Ramp, East Boston, from Porter Street to East Boston Portal; Callahan Tunnel East Boston Plaza hydrants.

#### General

In the event that a fire or accident is at or inside the entrance of either traffic tunnel for only a short distance, the first arriving engine company may proceed to the scene of the incident in the direction of flow of traffic, if not blocked by vehicles and it is safe to do so.

If a street fire alarm box in the vicinity of the entrance or exits of either tunnel is pulled for a fire or accident in either tunnel, the first arriving company shall immediately notify the Fire Alarm Office that the box was pulled for a fire in the tunnel, specifying whether it is the Sumner or Callahan. The Fire Alarm Office shall then notify the tunnel authorities so that they can assist the fire apparatus in getting to the scene as mentioned previously.

In the event of a fire with severe smoke conditions near the Ventilation Buildings on each side of the tunnels, the chauffeur of the District Fire Chief at the scene shall notify the Fire Alarm Office to inform the tunnel authorities so that necessary precautions can be taken to prevent smoke from being drawn into the tunnel.

Attention of the department is called to the change in the assignment of apparatus to Boxes 123 and 124 to the effect that Engine 25 will replace Engine 4 on the first alarm and that Engine 4 will replace Engine 25 on the second alarm. Necessary corrections shall be made on assignment cards.

Chief officers of the districts affected, including those who have companies in their districts which cover companies directly concerned with these evolutions, shall see that members of their commands are thoroughly familiar with the contents of this order through repeated drills.
