ARTISTS OF THE MEMORIAL



TED CLAUSEN, Artist

"My work for the Vendome Firefighters Memorial began as does each of my projects: with the word – the texts and stories of our lives. I use these stories as the key to our explorations of ourselves and our histories, both as individuals and as a collective culture. Through this central use of text, combined with my work's human scale, its sense of place, and its combination of materials, I hope to create thoughtful work which encourages a dialogue with each visitor."

Ted Clausen studied anthropology and psychology at the University of Redlands, CA before pursuing a graduate degree in design from the Kunstgewerbschule, Basel, Switzerland. His work has appeared in group exhibitions throughout the United States and in London, and since 1990 he has been honored with six solo exhibitions and a number of public art commissions. Mr. Clausen's work is represented in numerous collections, including The J. Paul Getty Center for the Study of Art and the Humanities, Santa Monica, CA; The Ruth and Marvin Sackner Archive for Concrete and Visual Poetry, Miami, FL; and Tufts University, Boston, MA. Mr. Clausen resides and works in Cambridge, MA.



PETER WHITE, Landscape Architect

"In my work as a landscape architect I am interested in designs which reflect upon and help us to appreciate more fully our relationship to the world. To me, the garden should offer us the opportunity to experience the play of light, form, texture, sound and smell, as well as provide for the spiritual and emotional self. For the past several years my interests and studies have focused on theories of Japanese garden design with specific emphasis on the use of stone and water. The Vendome Firefighters Memorial has allowed me the opportunity to incorporate another dimension into my work – the written word".

Peter White is the Senior Landscape Architect with Zen Associates, Inc. of Sudbury, MA. He has been practicing since 1985 after receiving his degree in Landscape Architecture at S.U.N.Y.E.S.F at Syracuse NY. He has created and built gardens throughout the eastern United States and Europe. Mr. White resides with his wife and three children in Winchester, MA.

Since 1990, Ted Clausen and Peter White have worked in collaboration as Third Floor Studio designing and building public art projects.

THE MEMORIAL

Twenty-five years ago nine Boston firefighters died in the line of duty when the southwest corner of the Hotel Vendome collapsed during a four-alarm fire. Today, a quarter of a century later, this long awaited memorial is dedicated to the memory of their spirit, selflessness and dedication to the Boston Fire Department and the people of Boston.

The memorial is the result of a five year effort by members of the Boston Fire Department to create a permanent tribute to the nine Boston Firefighters who perished on that tragic day and to honor the qualities of bravery, commitment, and integrity as embodied by Boston Firefighters throughout history.

The design was the result of a competition, funded by the Edward Ingersoll Browne Trust Fund. The winning design by Third Floor Studio features a sweeping black granite wall, etched with the names of the nine who died that day, a time line of the Hotel Vendome fire, and quotes from firefighters. The granite was imported from Zimbabwe, South Africa and was fabricated at Granite Industries of Vermont, Barre, VT. A bronze casting, cast at the King Foundry, Johnstown, RI, of a firefighter's helmet and fire coat sits atop the monument as if left there that afternoon in 1972. The plaza on which the piece sits is made up of light and dark pavers. There are 154 dark pavers, representing the 154 Boston Firefighters who have died in the line of duty from 1852 up to and including the Vendome fire. Major funding for the monument was provided by the Edward Ingersoll Browne Trust Fund and a fundraising effort by the Committee provided the balance.
