The Board of Fire Commissioners hereby announces to the Department that under the provisions of Chapter 354, Acts of 1886, Charles W. Whitcomb has been appointed Fire Marshal and assumed active duty. His headquarters have been established at No. 5 Pemberton Square, and telephonic communication has been made with the regular fire department system, and officers in command at fires will forward to the Fire Marshal information concerning alarms, in accordance with the following instructions:—

1st. All alarms, whether *public* or *still*, must be reported as soon as the "all out" signal has been given, by giving the *time* and *location*.

- 2d. Communication may be had by telephone with his headquarters between the hours of 9 A. M. and 5 P. M. on week days, except Saturday, when communication will be suspended at 2 P. M.
- 3d. On Sundays, Holidays, and at all hours not included above, information will be forwarded to the Fire Alarm office.
- 4th. The Fire Alarm Department will make record of such information received, and the Aid to the Marshal will call and take a transcript of same.
- 5th. Engineers will forward, in duplicate, their reports of all Alarms in their districts (as per Form No. 16) to this Board at the earliest possible moment.
  - 6th. The special daily reports of Alarms will be made to this Board as usual.

The Board enjoins on the Department cordial coöperation with the Fire Marshal in his efforts to discover the causes, and especially the criminal causes of fires. The greater the success attending his endeavors, the lighter will be the hazard and labor of the Department. Let it be remembered that we are all working in a common cause—the reduction of fire loss in the City of Boston, and the detection and punishment of those who are wilfully responsible for any part of that loss. All information should be given as promptly and made as lucid and comprehensive as possible. The creation of this new position is not intended to relieve the Department of the duty of investigation, in the slightest, but to give to the facts which it may obtain the system and emphasis which it has had neither time nor authority to impart to them in the past.
